

## Comprehensive Exhibit

This application seeks consent to assignment of the license of WVMY-LD, Parkersburg, West Virginia (Facility ID 182973) (the “License”) from Marquee Broadcasting, Inc. (“Marquee”) to commonly owned Marquee Broadcasting Ohio, Inc. (“MB Ohio”).

Both Marquee and MB Ohio are owned and controlled by spouses Brian Lane and Patricia Lane. While Patricia Lane, who currently exercises negative control over the License as a 50% owner of Marquee, will acquire positive control over the License as the 51% owner of MB Ohio, she has been a 50% owner of the License since Marquee acquired the License in 2017 (File No. BALDVL-20170804AAK, granted September 25, 2017). Moreover, while Patricia Lane will acquire *de jure* control over the License, *de facto* control will remain unchanged, and will be shared between spouses Brian Lane and Patricia Lane. Accordingly, use of the *pro forma* application Form 2100 Schedule 316 is appropriate.

As a purely internal assignment between two commonly controlled entities, there are no written agreements for this assignment.
