

## **Ownership and Control of the Proposed Assignee**

The proposed assignee, Shaw Local Radio Co. ("Shaw Local") is an Illinois corporation. 100% of the stock of Shaw Local is owned by Shaw Family Holdings, Inc. ("Shaw Family"), a Delaware corporation. 100% of the stock of Shaw Family is held by a trust, the Mabel Shaw Trust dt 2/24/1936 ("the Trust"). The Trust is to benefit the descendants of Mabel Shaw.

Trustee Services Group PLLC ("TSG") is the sole trustee of the Trust, and as such is solely responsible for management and all decision making with respect to the Trust assets.

TSG is an independent attorney owned professional fiduciary services company organized as a professional limited liability company under the laws of the state of Colorado. TSG is a Manager-managed PLLC. The Manager is appointed by a majority of its Members. The current Manager of TSG is its majority Member, Steven S. Marken who has a 98% Membership interest in TSG

Neither TSG nor any of its Members are "related or a subordinate party" to any of the Trust beneficiaries as those terms are defined by 26 CFR Section 1.672(c)(1).

As an independent attorney owned professional services company, TSG is not itself a family member of any of the beneficiaries, nor do its members have any familial relationship with any beneficiary. The Trustee has no personal or extra-trust business relationship to the beneficiaries. In such circumstances, Note d to Section 73.3555 of the FCC rules provides that interests of beneficiaries are not attributable except to "any person who had the sole power to sell such stock and to any person who has the right to revoke the Trust at will or to replace the Trustee at will." No beneficiary has the sole power to make such decisions. The Trustee can only be removed by a vote of 75% (by interest) of the current beneficiaries. There are currently 11 beneficiaries, so no beneficiary has the sole power to terminate the Trust, to replace the Trustee, or to sell the stock of Shaw Family held by the Trust. Thus, the beneficiaries, except where they are attributable for other reasons, are not attributable and are not listed on this form. Some beneficiaries or contingent beneficiaries are officers and directors of Shaw Family and Shaw Local and are reported in the assignee's section of the Form 314 application.
