**LKCM RADIO LICENSES, L.P.'S SUPPLEMENT TO PETITION TO DENY
MORTENSON BROADCASTING COMPANY OF TEXAS, INC.'S AMENDED
APPLICATION FOR AUTHORITY TO CONSTRUCT OR MAKE CHANGES IN AN
FM TRANSLATOR STATION**

On April 23, 2018, Mortenson Broadcasting Company of Texas, Inc. (hereinafter, "Mortenson"), filed an "Application for Authority to Construct or Make Changes in an FM Translator or FM Booster Station" (hereinafter, "Original Application") in connection with CH221D. On May 8, 2018, LKCM Radio Licenses, L.P. (hereinafter "LKCM") filed a "Petition to Deny" Mortenson's Original Application. On June 1, 2018, Mortenson filed a "Minor Amendment" (hereinafter, "Amended Application") to its pending Original Application and a "Technical Report Supporting a Form 349 Amendment to an Application for a New FM Translator Station" (hereinafter, "Report"). LKCM now files this Supplement to Petition to Deny Mortenson's Amended Application.

In its Report, Mortenson claims that its “amended operating parameters categorically resolve all 47 C.F.R. Section 74.1204(f) issues raised” (*see* Report, p. 1). This is not true. As fully explained below, although Mortenson did narrow the proposed coverage area of its FM translator station in its Amended Application, the proposed modification still fails to meet the required standards. Accordingly, Mortenson’s Amended Application must be dismissed.

In relevant part, 47 CFR 74.1204(f) provides as follows:

An application for an FM translator station will not be accepted for filing even though the proposed operation would not involve overlap of field strength contours with any other station...if the predicted 1 mV/m field strength contour of the FM translator station will overlap a populated area already receiving a regularly used, off-the-air signal of any authorized co-channel, first, second, or third adjacent channel broadcast station,...and grant of the authorization will result in interference to the reception of such signal.
(emphasis added)

Here, the predicted “1 mV/m field strength contour of the FM translator station” **will** overlap a populated area already receiving a regularly used, off-the-air signal—namely, that of KTFW-FM. Additionally, grant of the authorization to Mortenson **will** result in interference to the reception of the signal of KTFW-FM. Therefore, Mortenson’s Amended Application must be denied.

A. Testimonial Evidence Supports Denial of Mortenson’s Amended Application.

Attached in **Exhibit 1** are Declarations from listeners demonstrating they are listeners to KTFW-FM. The listeners have provided addresses from which that listening occurs. As seen in the exhibit, those addresses have been plotted on a map contained within the translator’s 60dBu contour as proposed in both the Original Application and Amended Application. If such Translator is to be granted and commence operations, listeners to KTFW-FM will be subject to destructive co-channel interference from that proposed Translator.

B. The Engineering Analysis Supports Denial of Mortenson's Amended Application

According to Mortenson's "Contour Protection Studies Toward Select Allocations Concern(s) Exhibit 7a" of the Amended Application, the 1 mV/m field strength of proposed Translator will overlap a populated area already receiving a regularly used off-the-air signal of KTFW-FM.

C. Public Policy Supports Denial of Mortenson's Amended Application

In relevant part, the Local Community Radio Act provides as follows:

Sec. 5. Ensuring availability of spectrum for low-power FM stations


The **Federal Communications Commission**, when licensing new FM translator stations, FM booster stations, and low-power FM stations, **shall ensure** that—

...(3) FM translator stations, FM booster stations, and low-power FM stations **remain** equal in status and **secondary to existing and modified full service FM stations**. (emphasis added)

If the Federal Communication Commission fails to deny Mortenson's Amended Application, it would fly in the face of the plain language of the Local Community Radio Act to ensure that FM translator stations remain secondary to stations such as KTFW-FM. It would also set a dangerous precedent with regard to future filings by other translator stations, as the intent of the law was never to make full service FM stations secondary to the translator stations.

For the foregoing reasons, LKCM respectfully requests that Mortenson's Amended Application be denied and dismissed.




