

MULTIPLE OWNERSHIP RULE COMPLIANCE

Bustos Media Holdings, LLC is the licensee of the following primary broadcast stations in the Tucson, Arizona radio metro market, as of March, 2023 the nation's 62nd largest such market:

- KVOI(AM), Cortaro, AZ, Facility ID #13969
- KTGTV(FM), Oracle, AZ, Facility ID #57504
- KZLZ(FM), Casas Adobes, AZ, Facility ID #36029

Tucson is the county seat of Pima County, Arizona, where Casas Adobes, Cortaro and Oracle, Arizona are all located.

By acquiring KDRI(AM), licensed to Tucson, AZ, Bustos Media Holdings, LLC would then be the licensee of two AM and two FM primary stations in the Tucson market.

According to the FCC's LMS database, there are at least eleven other full power AM stations and thirteen full power FM stations licensed to communities in Tucson, South Tucson or Corona de Tucson (see attached list), for a total of twenty-four primary broadcastd stations.

Therefore, since Bustos Media Holdings, LLC would own just four primary broadcast stations in a market of over 15 radio stations, where one party may own as many as six primary broadcast stations, a maximum of four in any one service, a grant of consent to the proposed acquisition of KZLZ(FM) would comply with the FCC's Multiple Ownership Rule, 47 C.F.R. §73.3555(a)(1)(iii).
