

## LOCAL RADIO OWNERSHIP

WQOR(AM), Olyphant, PA and WAZL(AM), Hazleton, PA are both located within the Wilkes Barre-Scranton, PA Nielsen Metro Survey Area. In addition, WGMF(AM), Nanticoke, PA and WGMM(AM), Tunkhannock, PA; attributable stations to Geos Communications, LLC; are also located within the Wilkes Barre-Scranton, PA Nielsen Metro Survey Area. This Assignment Application, if granted, would result in Geos Communications, LLC having 4 AM stations licensed within the Wilkes Barre-Scranton, PA Nielsen Metro Survey Area. The Wilkes Barre-Scranton, PA Nielsen Metro Survey Area has 46 radio stations licensed to the five counties that make up the market. This places this market in the largest tier of markets (45 or more stations). An organization is allowed to own up to 8 radio facilities with a maximum of 5 in any service (AM or FM). This assignment application proposes that Geos Communications would be the licensee of 4 radio facilities, all in one service (AM radio). This is allowable based on the FCC local radio ownership rules. Here is the list of stations (46 stations) licensed and located within the counties that make up the Wilkes Barre-Scranton, PA market which is the Wilkes Barre-Scranton, PA Nielsen Metro Survey Area.

In addition, Geos Communications is the licensee of WGMF-FM, Dushore, PA which is located in Sullivan County, PA. This county is not located within any Nielsen Metro Survey Area. WGMF-FM is not listed "Above the Line" in any Nielsen Metro Survey Area. In light of WGMF-FM not being located within any Nielsen Metro Market, the Contour method of Local Ownership Study will be used for this one case. See the attached contour map to this exhibit. WGMF-FM, Dushore, PA only overlaps WGMM(AM), Tunkhannock, PA and does not overlap the two proposed stations to be assigned within this application (WQOR(AM), Olyphant, PA and WAZL(AM), Hazleton, PA). It should be noted that WGMF-FM overlaps only one other Geos Communications radio station, WGMM(AM) and its 5 mV/m Contour. This is the only Geos Communications facility contour overlap. This would be an overlap of one FM facility and one AM facility. Section 73.3555(a)(1)(iv) of the FCC Rules allows for the ownership of one AM and one FM station with contours that overlap.
