PETITION TO DENY

LKCM Radio Licenses, L. P. licensee of KTFW, Facility 65314, Glen Rose, TX (LKCM), hereby respectfully submits and timely files its Petition to Deny the above referenced application for a construction permit for operation on Channel 221 to serve Fort Worth, TX.

Section 74.1204(f) of the Commission rules states:

An application for an FM translator station will not be accepted for filing even though the proposed operation would not involve overlap of field strength contours with any other station, as set forth in paragraph (a) of this section, if the predicted 1 mV/m field strength contour of the FM translator station will overlap a populated area already receiving a regularly used, off-the-air signal of any authorized co-channel, first, second or third adjacent channel broadcast station, including Class D (secondary) noncommercial educational FM stations and grant of the uthorization will result in interference to the reception of such signal.

The Commission stated that “it will not grant an application if an objecting party provides convincing evidence that the proposed translator station would be likely to interfere with the reception of a regularly received off-the-air service, even if there is no predicted overlap.”


The proposed Mortenson (FX) operates on co-channel Channel 221. Although the applicant does not predict overlap of the existing 60 dBu contours of the NEW Translator and the contour of KTFW, in actuality there are numerous listeners served by KTFW within the newly proposed 60 dB μ contour of Mortenson’s proposed application. These existing listeners will be subject to co-channel interference once the proposed station begins operation.

Attached as Attachment 1 are Declarations from listeners demonstrating that they are listeners to KTFW. The listeners have provided addresses from which that listening occurs. As seen in Exhibit 1 of that Attachment, those addresses have been plotted on a map containing the proposed translator’s 60 dBu contour. If such translator were to be granted and commence operations, listeners to KTFW will receive destructive interference from that proposed translator.

Therefore, under Section 74.1204(f), that application should not remain accepted for filing, and may not be approved. To avoid the grant of an application that will adversely affect existing Station KTFW listeners and service, it is respectfully requested that the application be denied and dismissed.

WHEREFORE, as of May 8, 2018, it is requested that this Petition to Deny be granted, and the pending application for issuance of a construction permit for Channel 221 be denied.




