STA Request Explanation

Channel 51 of San Diego, Inc. (Channel 51) requests to extend Special Temporary Authority (STA) to operate K12PO consistent with the authority granted in File No. 0000195120. K12PO is currently unable to broadcast at its licensed parameters owing to the presence of a federally protected birds nest on the tower that was preventing tower work. Channel 51 anticipates that this will be the last request to extend the STA as the birds recently left the nest and tower work can now be scheduled.
