The KONQ license is to be transferred without consideration, pursuant to Resolution No. 2023-06, adopted by the Board of Trustees of Dodge City Community College. Attached is a copy of the resolution. There is no other documentation for the transfer.

RESOLUTION NO. 2023-06

A RESOLUTION TO TRANSFER FM BROADCAST STATION LICENSE FOR KONQ-GM TO KANZA SOCIETY, INC. d/b/a HIGH PLAINS PUBLIC RADIO.

WHEREAS, in 1977 KINF-FM went on the air as the Dodge City Community College radio station with its studio on the Dodge City Community College campus;

WHEREAS, in 1992 Dodge City Community College acquired KEDD-AM from Seward County Broadcasting Company, Inc. The call sign was changed to KDCC-AM;

WHEREAS, on March 22,1993, the call sign for the radio station was changed to KONQ-FM;

WHEREAS, in 1996 the studios for KONQ-FM were moved to 3004 North 14th Avenue, Dodge City, Kansas;

WHEREAS, Dodge City Community College used both radio stations for broadcasting classes and later used the stations to promote Dodge City Community College athletic programs;

WHEREAS, in 2015 Dodge City Community College entered into a programming agreement with Kanza Society, Inc., whereby High Plains Public Radio broadcasts its programs a portion of each broadcast day on KONQ-FM;

WHEREAS, broadcasting classes are no longer offered by Dodge City Community College and Dodge City Community College athletic events are no longer broadcasted by the radio stations;

AND WHEREAS, pursuant to K.S.A. 71-201(b)(11), the Dodge City Community College Board of Trustees has determined the radio broadcast licenses are no longer necessary for college purposes and should be disposed of.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF DODGE CITY COMMUNITY COLLEGE AS FOLLOWS:

Section 1. The broadcast station license for KONQ-FM shall be transferred to Kanza Society, Inc., d/b/a High Plains Public Radio, a Kansas not-for-profit corporation.

Section 2. The transfer shall be without financial consideration and intended to improve access to public radio services in and around Dodge City, Kansas.

Section 3. The Board Chair is hereby authorized to execute all documents incidental to the transfer of the broadcast station license for KONQ-FM to Kanza Society, Inc.

Section 4. This resolution shall take effect upon adoption.
