The WADO transmitter site is leased from the State of New Jersey through the New Jersey Department of Environmental Protection (NJDEP). One of the only outstanding conditions to closing calls for a finalized lease for that site.

The parties expect NJDEP to release a draft lease in the near future. However, it is not clear whether the parties will complete closing by the consummation deadline, as presently extended.
