

# WUPL

## License Renewal Application Public Inspection File – Supplemental Exhibit

Belo TV, Inc. (“Licensee”), licensee of WUPL, New Orleans, Louisiana (“WUPL”), files this Supplemental Exhibit in response to the Media Bureau staff’s request for additional information regarding WUPL’s online public inspection file.

As disclosed in WUPL’s license renewal application, certain documents were prematurely removed from WUPL’s OPIF during the prior license term and reloaded when Licensee discovered the issue. In response to the staff’s request, Licensee has reviewed WUPL’s OPIF history records as accessed through the Commission’s OPIF Service Data API,<sup>1</sup> as well as Licensee’s own records and other sources. The chart below sets forth the affected documents. Except where otherwise indicated, the information is drawn from WUPL’s OPIF history records, the relevant portions of which are attached hereto as Attachment 1.

In addition to the foregoing:

- WUPL’s children’s television programming reports for the second quarter of 2013 through the second quarter of 2014 were timely filed through CDBS, as shown in the links to those reports available in the station’s OPIF. However, at some point following the grant of the station’s last license renewal application, the station erroneously set these filings to no longer be visible in the OPIF. This issue was corrected on or about January 6, 2017.
- The station’s 2013-2014 EEO annual public file report appears to have been uploaded to the station’s OPIF on February 2, 2015. However, an Internet Archive snapshot of the station’s website homepage, captured on July 31, 2014,<sup>8</sup> links to a copy of the report with metadata showing the report was last edited on January 17, 2014, indicating that the report was prepared and made publicly available by that time.<sup>9</sup>
- The station’s 2015-2016 EEO annual public file report appears to have been uploaded to the station’s OPIF on January 9, 2017. However, an Internet Archive snapshot of the station’s website homepage, captured on February 1, 2016, links to a copy of the report with metadata showing the report was last edited on January 25, 2016, indicating that the report was prepared and made publicly available by that time.<sup>10</sup>
- The station’s issues/programs list for the second quarter of 2021 was uploaded on July 14, 2021.
- The station’s issues/programs list for the first quarter of 2023 was uploaded on July 10, 2023.
- In preparing this Supplemental Exhibit, the station determined that the annual commercial limits certification uploaded on April 4, 2022, erroneously referred to programming aired during 2022, when the certification should have referred to programming aired during 2021. A revised certification was uploaded on August 18, 2023.
- In preparing this Supplemental Exhibit, the station determined that the annual commercial limits

certification for programming aired during 2022 had not been timely uploaded. The certification was uploaded on August 18, 2023.
