Request for Extension of Special
Temporary Authority to Remain Silent

Dear Mr. Moskowitz:

This letter concerns the request you filed on August 30, 2023, on behalf of Langer Broadcasting Group, LLC (LBG), for extension of Special Temporary Authority (STA) to permit AM Radio Station WZBR to remain silent.

Commission records reflect that LBG stated that Station WZBR(AM) went silent on March 5, 2023, for financial reasons. The previous STA was granted on March 22, 2023, and expires on September 21, 2023. LBG requests extension of its STA for continuing financial reasons.

LBG's request is granted. Accordingly, Special Temporary Authority is granted to permit Station WZBR(AM) to remain silent until March 5, 2024. **Notwithstanding the grant of this Special Temporary Authority, the broadcast license for Station WZBR(AM) will automatically expire as a matter of law if broadcast operations do not resume by 12:01 a.m., March 6, 2024.**¹

LBG is required to notify the Commission when broadcast operations resume.² If LBG does not file the notification of resumption of operations in a timely manner, the license may be subject to cancellation pursuant to section 312(g) of the Communications Act, as amended.³

The station's silent status does not suspend the licensee's obligation to comply with all other relevant Commission rules, including the filing, when appropriate, of applications for renewal of

The records shall include start/stop dates and times of such operation. These log entries must be maintained for a minimum of two years as specified in 47 CFR § 73.1840(a), unless a longer retention period is requested by the staff. Periods of operation may be subject to independent verification that they in fact occurred.

broadcast license. It is imperative to the safety of air navigation that any prescribed painting and illumination of the station's tower shall be maintained until removed.⁴
