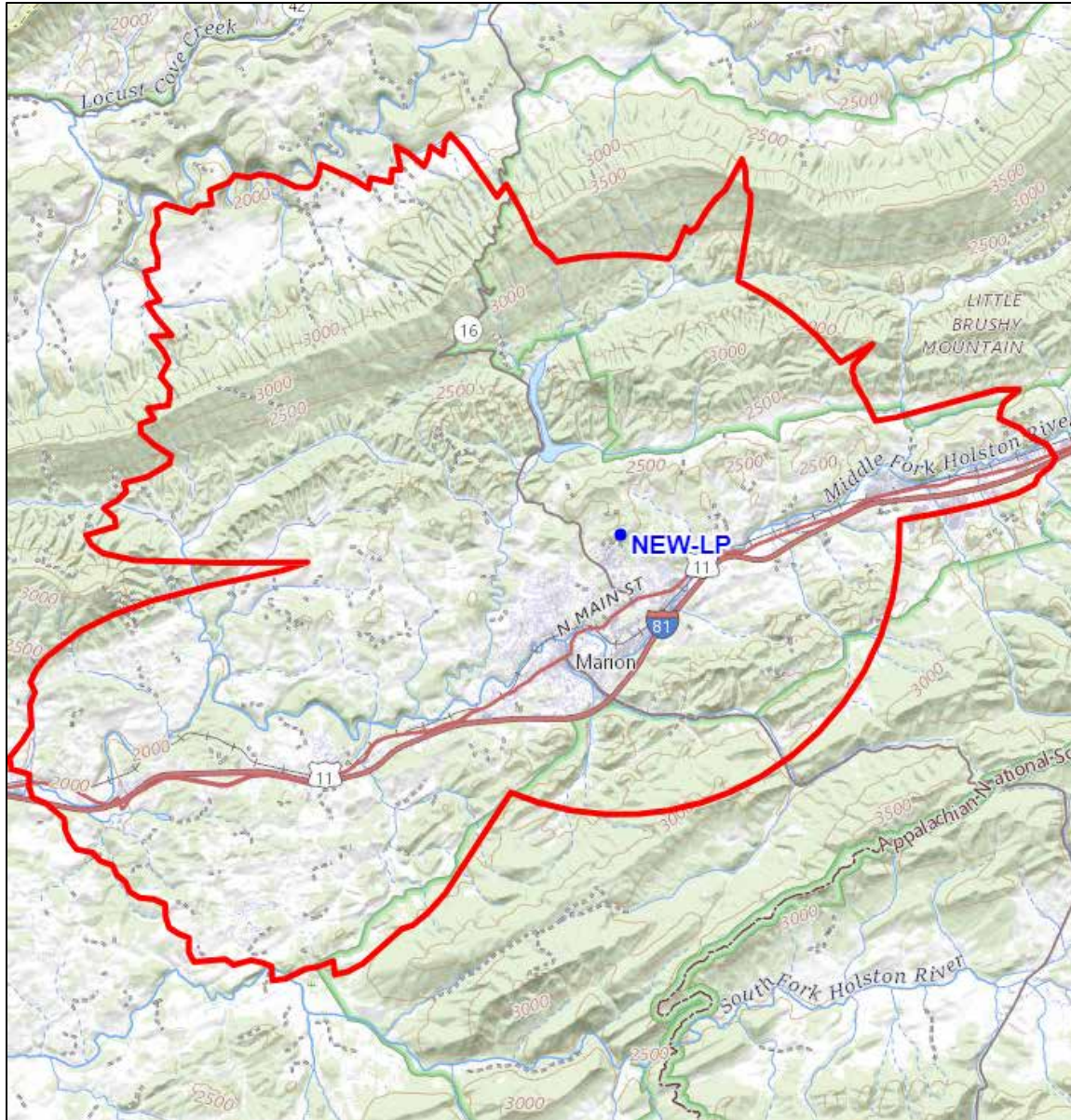

INSTALLATION ON AN ACTIVE AM BROADCAST TOWER

New(LP)
Marion, Virginia
Channel 227LP100 (93.3 MHz)

The instant application proposes a new LPFM station to be placed on the "hot" tower of diplexed AM stations WUKZ(AM), Marion, Virginia (Facility ID No. 63710) and WHNK(AM), Marion, Virginia (Facility ID No. 19478).

WUKZ(AM) is a nondirectional Class D AM station operating on 1010 kHz with 1 kW, daytime only.

WHNK(AM) is a nondirectional Class D AM station operating on 1330 kHz with 1 kW, daytime only.

As this is proposed for installation on a nondirectional AM tower, the provisions of §1.30003(a) apply. The rules require that when antennas are installed on a nondirectional AM tower, the AM station shall determine the operating power by the indirect method, pursuant to §73.51. Upon completion of the installation, impedance measurements on the AM antenna shall be made and if the resistance changes by more than 2 percent, an application must be filed by the AM station to return to direct power measurement.

The AM station has been notified.

The applicant is aware of these conditions.

With respect to the licensing requirements governing all noncommercial educational ("NCE") facilities, the Commission has stated that religiously oriented applicants can meet its NCE eligibility standards where the applicant proposes an overall educational program, and its proposed programming furthers its educational objectives.

The applicant will work with both local religious and secular charitable institutions, as well as other community, civic, government, NGO (non-government organizations), and other not-for-profit organizations to assist and complement existing efforts to administer to the spiritual, intellectual, and physical needs of the listening audience.

The station will be funded exclusively by the congregation of Trinity Chapel, as well as by individual members of Trinity Chapel. No advertising of any kind will be accepted.

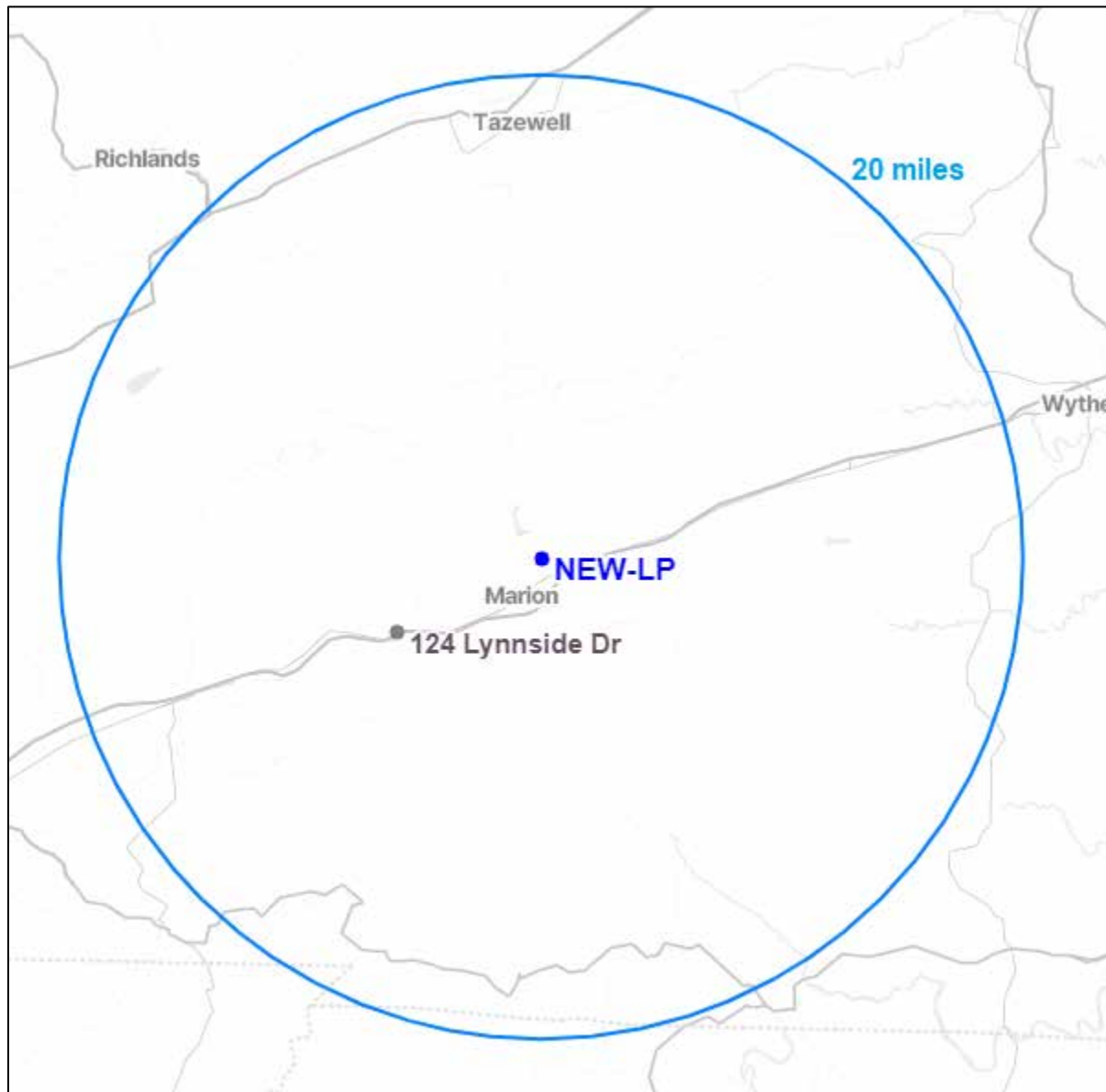
