Thank you again for you and Chris's time to chat. We just wanted to just confirm the information that was provided.

1. The pictures provided were the complete set.
2. The difference of where the transmitter is located in certain pictures was because the transmitter was relocated during the process of installation and taking the pictures.
3. The pictures were taken on July 31, 2023, as time stamped, which was also the date the installation was conducted and completed.
4. The outdoor antennas are not aimed at any particular azimuth.
5. The antennas pictured inside the building are receive antennas aimed at the Empire State Building.
6. The equipment inside the cabinet was assembled by the licensee or some other person, but not your staff.
7. The outdoor antennas shown are connected to the transmitter cabinets inside.
