

**REQUEST FOR WAIVER OF §73.807(a)**  
**SHORT-SPACED SECOND-ADJACENT CHANNEL**

New(LP)  
Fort Myers, Florida  
Channel 264LP100 (100.7 MHz)

The instant application meets all §73.807 distance separation requirements with the exception of second-adjacent channel station WAVV, Naples Park, Florida. To address this shortcoming, we propose the following as set forth:

WAVV operates on Channel 266C1 with 100 kW effective radiated power (ERP) at 289.9 meters height above average terrain (HAAT) into a nondirectional antenna. WAVV places a 70.4 dBu service contour at the proposed transmitter site.

Pursuant to §73.811(a) of the Commission's Rules, the proposed facility is specifying operation at 25 watts (0.025 kW) ERP.

Using the U/D method<sup>1</sup>, the proposed LPFM station is predicted to produce an undesired interference overlap in respect to WAVV to the proposed LPFM station's 110.4 dBu interfering contour ("overlap zone"). At 25 watts ERP, the overlap zone extends to 106 meters from the base of the antenna structure utilizing the free space method.

As the interference would reach the ground, the applicant can overcome the second-adjacent channel interference utilizing a single bay Nicom BKG-77 circularly polarized antenna. Based on the manufacturer's specifications, the overlap zone would not reach any point lower than 11 meters above ground level. There are no adjacent tall buildings within 106 meters of the proposed site.


As we have determined that the proposed facility will not cause any interference, the applicant is requesting a waiver of §73.807(a) in respect to WAVV, Naples Park, Florida.


