The proposed KKLS modifications will maintain the common ownership of the following six stations in the Rapid City area:

KBHB(AM)	Sturgis, SD	810 kHz
KKLS(AM)	Rapid City, SD	920 kHz
KRCS(FM)	Sturgis, SD	Channel 226C0
KKMK(FM)	Rapid City, SD	Channel 230C1
KOUT(FM)	Rapid City, SD	Channel 254C1
KFXS(FM)	Rapid City, SD	Channel 262C1

None of these stations have principal community contour overlap with any other commonly owned station.

None of these six stations are presently assigned to a Nielsen Audio market.¹ Nor are the communities of license of any of these six stations located within the geographic boundaries of any Nielsen Audio market. As a result, the metro market methodology for defining radio markets is not applicable to this situation.

For this reason, as required by Paragraph 286 of the FCC's July 2, 2003 *Report and Order and Notice of Proposed Rulemaking* in MB Dockets 02-277, 01-235, 01-317, 00-244, and 03-130, contour overlap studies were conducted for the market defined by the principal community contour overlap between KBHB, KRCS, KKMK, KOUT, KFXS, and the modified KKLS facilities.² Attached is a map exhibit depicting the principal community contours for these six stations. The 5 mV/m daytime contour for KBHB was projected using the notified facilities from the FCC's License Management System ("LMS")

¹All six of these stations were previously considered to be part of the Rapid City, South Dakota Nielsen Audio market, but Nielsen eliminated the Rapid City market on July 28, 2023. As a result, it is necessary to evaluate this situation using a contour overlap analysis.

²These contour overlap studies were conducted utilizing the modified contour overlap methodology outlined in Paragraph 285 of the FCC's July 2, 2003 *Report and Order and Notice of Proposed Rulemaking* in MB Dockets 02-277, 01-235, 01-317, 00-244, and 03-130.

and conductivity data from FCC Figure M3. The 3.16 mV/m contours for KRCS, KMKK, KOUT and KFXS were projected using the notified facilities for each station from the LMS and terrain data extracted from the NGDC 30 second terrain database. The proposed 5 mV/m daytime contour for KKLS was projected using the proposed facilities and measured conductivity data from the KKLS 1978 full proof of performance, supplemented with conductivity data from FCC Figure M3 in areas where this measured conductivity data was not applicable. As shown in this figure, there is an area of common principal community overlap between all six of these commonly owned stations. Thus, these six stations form a single contour based market for the purposes of this analysis.

An attached figure shows the composite principal community contour for the contour based market formed by these six commonly owned stations. Also shown in this figure are the transmitter sites of all operating stations located within this contour. The attached table is a tabulation of the stations depicted in this figure. As shown by this data, there are 32 stations, including KBHB, KKLS, KRCS, KMKK, KOUT, and KFXS in this contour based market. Thus, it can be safely said that there are at least 32 stations in the contour based market defined by the principal community contours of these six stations. In fact, the number of stations in this market would be even greater if stations located outside this composite contour whose principal community contours overlap this composite contour were included in this total. No such further analysis is required in this case, however, since, in markets containing 30 to 44 stations, Section 73.3555(a)(1)(ii) of the FCC Rules permits the common ownership of up to 7 commercial stations, not more than 4 of which are in the same service. The instant situation involves the com-

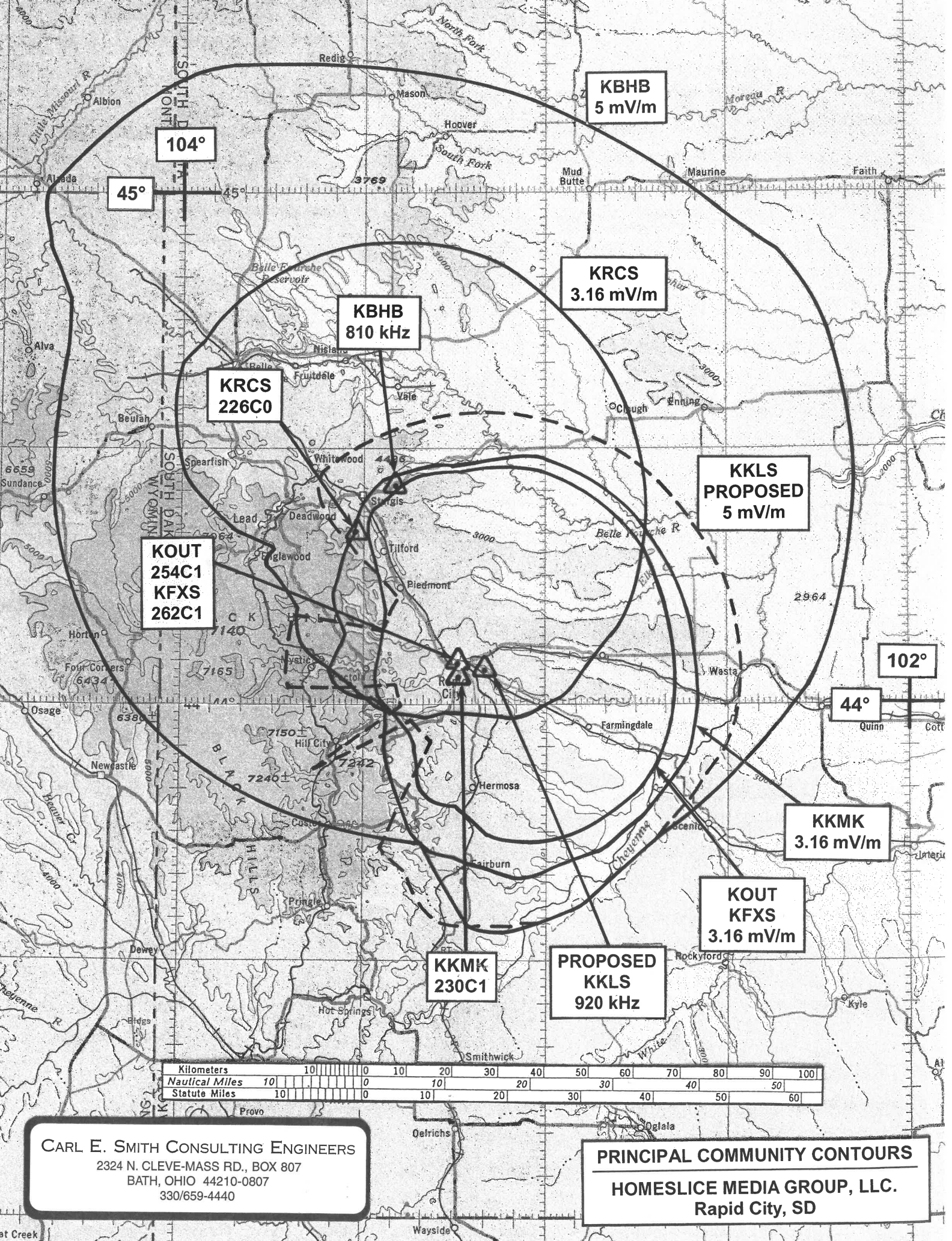

mon ownership of two AM stations and four FM stations in this contour based market, which does not exceed the permitted maximum.

Based upon the above information, the common ownership of these six stations will continue to fully comply with the local radio ownership restrictions specified in Section 73.3555 of the FCC Rules.

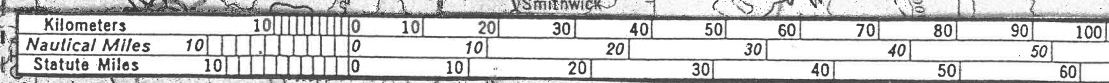

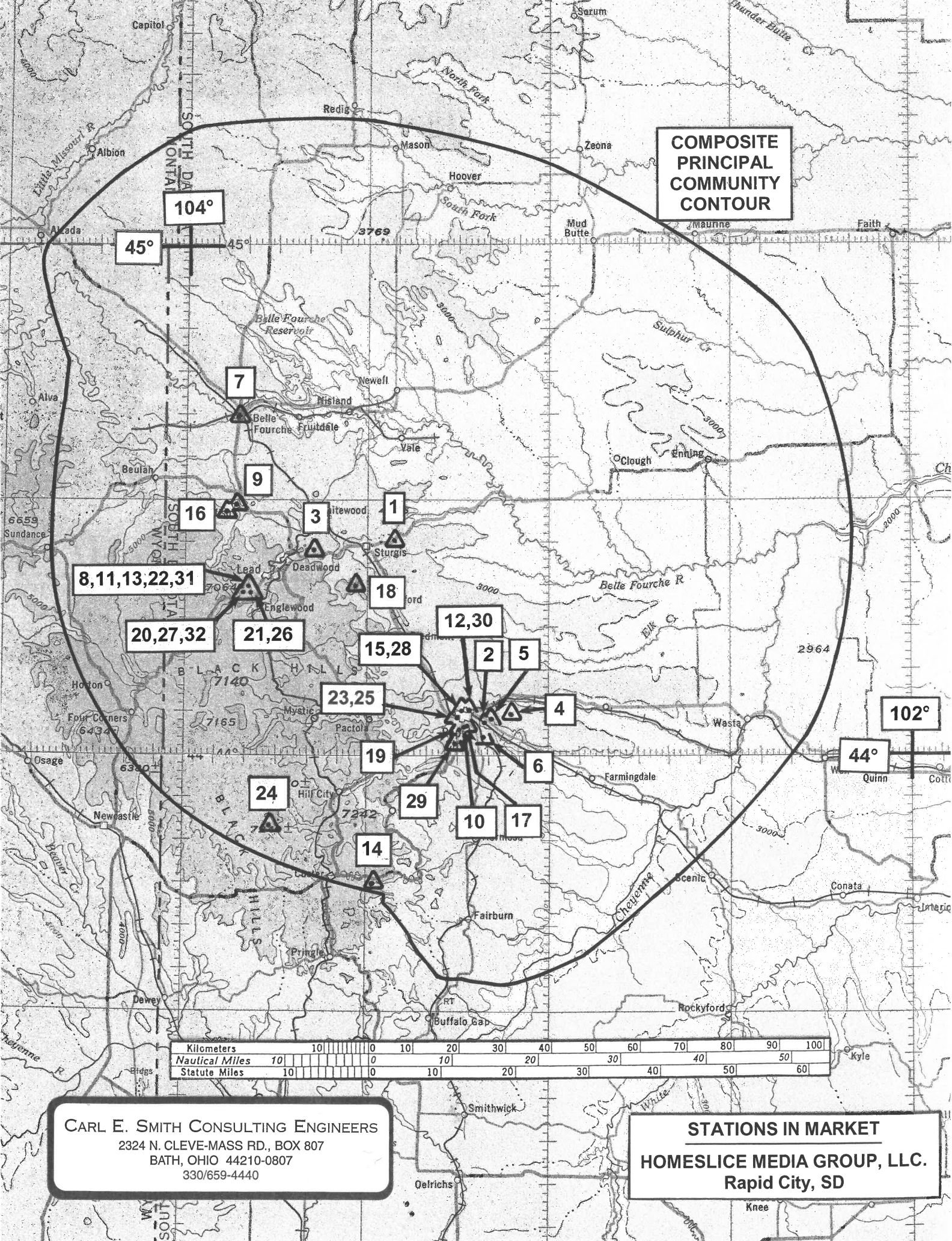
