Request for Special
Temporary Authority to Remain Silent

Dear Mr. Trent:

This letter concerns the request you filed on October 10, 2023, on behalf of Massanutten Military Academy (MMA), for Special Temporary Authority (STA) to permit Low-Power FM Radio Station WUDS-LP to remain silent.

MMA's request states that Station WUDS-LP went silent on October 10, 2023, for staffing reasons.

MMA's request is granted. Accordingly, Special Temporary Authority is granted to permit Station WUDS-LP to remain silent not to exceed 180 days from the date of this letter. **Notwithstanding the grant of this Special Temporary Authority, the broadcast license for Station WUDS-LP will automatically expire as a matter of law if broadcast operations do not resume by 12:01 a.m., October 11, 2024.**¹

MMA is required to notify the Commission when broadcast operations resume.² If MMA does not file the notification of resumption of operations in a timely manner, the license may be subject to cancellation pursuant to section 312(g) of the Communications Act, as amended.³

The station's silent status does not suspend the licensee's obligation to comply with all other relevant Commission rules, including the filing, when appropriate, of applications for renewal of
