Ave Maria Communications (AMC) is a non-stock, non-profit corporation originally organized in Michigan on July 23, 1995, which restated its Articles of Incorporation on July 7, 2007 (see attached). It proposes to operate the following FM Broadcast Stations as non-commercial, educational stations in accordance with Section 73.503 of the FCC's Rules: WNOC, Bowling Green; WFOT, Lexington; WHRQ, Sandusky; WRRO, Edon; and WSHB, Willard, all Ohio.

Educational Mission of AMC

AMC was formed to, *inter alia*, engage in educational activities. It has been granted tax exempt status pursuant to 26 U.S.C §501(c)(3) by the Internal Revenue Service.

In practice, AMC's educational mission involves the following:

a. For providing regular educational programming designed to teach the Bible and the Catechism of the Roman Catholic Church in a manner which can be utilized by local Roman Catholic schools as well as by the Confraternity of Christian Doctrine educational programs administered by local Roman Catholic parish churches.

b. Working with Roman Catholic educational and contemplative institutions, including but not limited to Franciscan University of Steubenville in Ohio and Our Lady of the Angels Monastery in Alabama, for the presentation of

quality educational programming.

c. For providing programming which can be used to train laymen for an active and effectual role in Roman Catholic parish life, such as lector, catechism teacher, etc.

AMC has worked with WDEO(AM), Ypsilanti, Michigan and WMAX(AM), Bay City, Michigan to develop a 24 hour per day, seven day per week program format, which it intends to implement on stations WNOG, WFOT, WHRQ, WRRO and WSHB. A schedule is attached (this is subject to change

Programming In Furtherance of AMC's Educational Mission

AMC produces a number of radio programs which are distributed nationally and will be broadcast over WNOG et al. These include:

- “Kresta in the Afternoon”, Monday-Friday 4-6 pm, with host Al Kresta, a two-hour talk program featuring long form interviews and discussions on all areas of life viewed through the lens of Catholic teachings on scripture and tradition.
- “Catholic Connection”, Monday-Friday 8-10 am, with host Teresa Tomeo, a well-known media personality and professional speaker in southeastern Michigan. She discusses social issues, media awareness, and interviews local businesses, youth, families, and community leaders.
- “More 2 Life”, Monday-Friday, 10-11 am, with hosts Dr. Greg Popcak and Lisa Popcak. This is a program that discusses the “Theology of the Body” of Pope of John Paul II into the practical, everyday experience of life. Dr. Greg and Lisa help solve problems with relevant, relatable and achievable tools and solutions straight from the genius of the Theology of the Body. It is the life you were meant to live!
- “Christ Is the Answer: Monday-Friday, 11 am-12 noon, with host Fr. John Riccardo. This is a program where a Catholic priest provides instruction on the Catechism of the Catholic Church and other timely

topics

- “The Doctor Is In”, Monday-Friday, 1-2 pm, with host Dr. Ray Guarendi, a clinical psychologist. Parenting issues from diaper dilemmas to teenage traumas to college crises along with family, personal and professional life issues are dealt with in a straight-forward, no-nonsense, and often humorous way.

Other programming to be aired by AMC over WNOC et al. will come from the radio service of Eternal Word Television Network (EWTN). EWTN is headquartered on the former site of Our Lady of the Angels Monastery in Irondale, Alabama, which was founded and operated by the Roman Catholic order of nuns known as Poor Clares of Perpetual Adoration. EWTN's founder was Mother M. Angelica, P.C.P.A. The main purpose of EWTN was described by Mother Angelica as "catechesis": that is, the teaching of the Gospel of Jesus Christ and the Catechism of the Roman Catholic Church.

EWTN's programming is commercial-free, and there is no paid programming which is aired on EWTN. Such programming would be broadcast over KYTR(FM) in a commercial-free manner. Programming consists of the following basic types: (1) rebroadcasts of "Interactive" programs which involve a host or moderator and call-in questions from listeners; (2) recorded programs presented by eminent Roman Catholic professors and scholars dealing with various topics of the Gospels and Roman Catholic catechism (categories 1 and 2 occupy a majority of the broadcast day); (3) Roman Catholic Masses, the Holy Rosary and

various recitations of various devotionals; and (4) news programs known by the titles "Catholic World Today" and "The World Over".

Thus, the programming to be presented on WNOC et al. constitutes a comprehensive Monday-Friday effort to educate the public, Catholics and non-Catholics, about the tenets and dogmas of the Roman Catholic faith, including the Bible and the systematic Catechism of the Roman Catholic Church. AMC will work with local Roman Catholic organizations throughout northwest Ohio, where all five stations are located to assist their educational efforts.

RESTATED ARTICLES OF INCORPORATION
OF
AVE MARIA COMMUNICATIONS

Pursuant to the provisions of Act 162, Public Acts of 1982, the undersigned corporation executes the following Restated Articles:

1. The present name of the corporation is: Ave Maria Communications
2. The identification number assigned by the Bureau is: 737912
3. All former names of the corporation are: Credo, Ltd.
4. The date of filing the original Articles of Incorporation was: October 23, 1995.

The following Restated Articles of Incorporation supersede the Articles of Incorporation as amended and shall be the Articles of Incorporation for the corporation:

ARTICLE I

The name of the corporation is: Ave Maria Communications.

ARTICLE II

The purpose or purposes for which the corporation is organized are:

1. This organization is organized exclusively for religious, nonprofit, educational, and scientific purposes that qualify as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), primarily receiving and administering funds to support the advancement of the Roman Catholic faith and the Apostolic Mission of the Church, including evangelization and education of the Faith, through support of educational institutions which operate consistently with *Ex Corde Ecclesiae*, and through the use of all forms of current day media, including without limitation, radio, television, motion pictures and global telecommunications networks. Fidelity to the Magisterial Teaching of the Church shall be observed by the organization throughout its existence it

being the stated intention and desire of the directors and trustees of the Ave Maria Communications that the corporation shall retain in perpetuity its identity as such an organization. With such essential character in mind, the purposes of the corporation include, but are not limited to the following:

- A. To support educational institutions that teach the principles of the Catholic tradition and the moral and social teachings of the Roman Catholic Church, and such other subjects of investigation relating or appertaining thereto and the students that attend such institutions;
 - B. To support the education of the general public in the teachings, precepts, tenets, purposes, personalities, clergy and saints of the Church through operation or support of radio and television stations, syndicated radio and television programming and through the commissioning and distribution of tapes, compact discs, books, artwork, movies and similar works of authorship, either directly or through support of organizations, institutions or corporations that engage in such activities;
 - C. To serve the common good, as elaborated in the moral and social teachings of the Roman Catholic Church;
 - D. To foster the kingdom of God on earth through teaching the inherent dignity of every human being, a dignity based on our creation in the image and likeness of God and raised to a new level by our redemption in Jesus Christ.
2. The corporation shall not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws.

ARTICLE III

1. The corporation is organized on a stock basis. The number of shares that the corporation is authorized to issue is 100 and all shares have equal rights and preferences.

3. The description and value of its personal property assets are: NA
4. The corporation is to be financed under the following general plan: NA

ARTICLE IV

1. The address of the registered office is: 24 Frank Lloyd Wright Dr., Ann Arbor, Michigan 48105
2. The name of the registered agent is: Al Kresta.

ARTICLE V

- A. This corporation is organized and operated exclusively for charitable, religious, scientific and educational purposes, within the meaning of Sections 170(c)(2), 501(c)(3), 2055(a)(2), and 2522(a)(2), of the Internal Revenue Code of 1986, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, or future amendments of said sections.
- B. No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by:

- (1) any organization exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986 as an organization described in Section 501(c)(3) of such Code;
- (2) an organization described in Section 509(a)(1), (2) or (3) of the Internal Revenue Code of 1986 (as the case may be); and/or
- (3) an organization, contributions to which are deductible under Sections 170(c)(2), 2055(a)(2), or 2522(a)(2) of the Internal Revenue Code of 1986.

ARTICLE VI

A volunteer director of the Corporation shall not be personally liable to the Corporation or its shareholders or members for monetary damages for breach of the volunteer director's duty, except for liability:

- (1) For any breach of the volunteer director's duty of loyalty to the Corporation or its shareholders or members;
- (2) For acts or omissions not in good faith or that involve intentional misconduct or knowing violation of law;
- (3) For a violation of Section 551(1) of the Michigan Nonprofit Corporation Act;
- (4) For any transaction from which the volunteer director derived an improper personal benefit;
- (5) For any acts or omissions occurring before the date this Article is filed by the Michigan Department of Consumer and Industry Services; and
- (6) For any acts or omissions that are grossly negligent.

If the Michigan Nonprofit Corporation Act is hereafter amended to authorize the further elimination or limitation of the liability of directors of nonprofit corporations, then the liability of a director of the Corporation (in addition to the limitation, elimination and assumption of personal liability contained in this Article) shall be assumed by the Corporation or eliminated or limited to the fullest extent permitted by the Michigan Nonprofit Corporation Act as so amended, except to the extent such limitation, elimination or assumption of liability is inconsistent with the status of the Corporation as an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, or comparable provisions of subsequent legislation.

No amendment or repeal of this Article shall apply to or have any effect on the liability or alleged liability of any director of the Corporation for or with respect to any acts or omissions of such director occurring prior to the effective date of any such amendment or repeal.

ARTICLE VII

Provided that such indemnification does not violate the status of the Corporation as an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, or comparable provisions of subsequent legislation, each person who is or was an officer of the Corporation or a member of the Board of Directors, and each person who serves or has served at the request of the Corporation as a director, officer, partner, trustee, employee, agent or committee member of any other corporation, partnership, joint venture, trust or other enterprise shall be indemnified by the Corporation to the fullest extent permitted by

the corporation laws of the State of Michigan as they may be in effect from time to time. The Corporation may purchase and maintain insurance on behalf of any such person in any such capacity or arising out of his status as such, whether or not the Corporation would have power to indemnify him against such liability under the laws of the State of Michigan. This right of indemnification shall continue as to a person who ceases to be a director or officer, and shall inure to the benefit of the heirs, executors, and administrators of that person.

ARTICLE VIII

Any action that may be taken by the Board of Directors at a meeting may be taken without a meeting if a consent in writing, setting forth the action to be taken, shall be previously signed by all of the Directors or if signed by the number of Directors required pursuant to Michigan law providing for such consents, whichever is fewer.

ARTICLE IX

A Director shall be deemed to be personally present for the conduct of business at any meeting of the Board of Directors if Director participates by means of a conference telephone or similar communications equipment through which all persons participating in the meeting can hear each other and discuss the matters presented to the Board.


ARTICLE X

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the Circuit Court of Washtenaw County, Michigan, if the principal office of the corporation is located in the said county at the time of dissolution of the said corporation, or by the Circuit Court (or equivalent thereof) of the county in which the principal office of the corporation is then located, exclusively, for such purposes or to such organization or organizations, as the said Court shall determine, which are organized and operated exclusively for such purposes.

These restated Articles of Incorporation were duly adopted by consent dated * in accordance with the provisions of Section 642 of the Act. These Restated Articles of

Incorporation restate, integrate, and do further amend the provisions of the Articles of Incorporation and were duly adopted by the directors. The necessary number of votes were cast in favor of these Restated Articles of Incorporation.
