I am writing this correspondence to inquire whether there is a local marketing agreement, as discussed in section 8(c) of the Asset Purchase Agreement, and First Amendment and Assignment to Asset Purchase Agreement. Additionally, KEPS(AM), Fac. ID No. 18107, Eagle Pass, Texas went silent on June 30, 2022 and thus must resume broadcast operations by 12:01 a.m., July 1, 2023. On June 12, 2023, the Audio Division granted special temporary authority (File No. BSTA-20230608AAA) to station KEPS(AM) to operate with temporary facilities from an alternate site location that expire December 9, 2023. Did the station resume operations? If so, we request the filing of the resume operations application.
