State of Oklahoma.

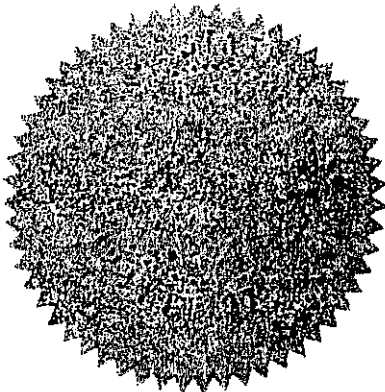

ARTICLES OF INCORPORATION
OF

UNITARIAN UNIVERSALIST FELLOWSHIP OF NORMAN, OKLAHOMA
"A Non-Profit Organization"

Know all men by these presents, that we, whose names are hereunto subscribed, do hereby associate ourselves together for the purpose of forming a religious corporation under the provisions of the non-profit corporate laws of the State of Oklahoma, and for that purpose state:

ARTICLE I.

The name of this corporation shall be:

UNITARIAN UNIVERSALIST FELLOWSHIP OF NORMAN, OKLAHOMA ^{OK} _{vn}

ARTICLE II.

The purpose for which this Corporation is formed is to bring religious liberals into closer acquaintance and cooperation for the study and practice of religion, and for the diffusion of the knowledge of Unitarianism and Universalism, and the furthering of their principles.

ARTICLE III.

This corporation does not and shall not afford pecuniary gain, incidentally or otherwise, to its members.

ARTICLE IV.

This corporation shall continue to exist perpetually. ✓
