

Jill Walker Ministries – Educational Program

Jill Walker Ministries (“JWM”) was incorporated as a Not For Profit in the State of Illinois on February 10, 1986. Since that time, the ministry has led a church in Lovington, IL beginning in 1989, and Mattoon, IL beginning in 2011. JWM intends to use this LPFM station as a means to deliver religious services to those who are unable to attend church services. In addition, JWM intends to deliver daily religious teaching, religious music, community information, and to serve those in the Mattoon area seeking religious values and positive guidance.

This station intends to operate 24 hours a day. Planned programming includes religious services each Sunday morning, Sunday evening, and Wednesday evening, religious teaching throughout each day, and locally programmed music during the day, evening, and overnight periods.
