**USE OF THE STATION FOR
ADVANCEMENT OF AN EDUCATIONAL PROGRAM**

The sole purpose of this application is to convert station KKLL(AM) from commercial status to non-commercial educational status.

Catholic Radio Network, Inc. (CRN) was formed as a Section 501(c)(3) non-profit corporation "exclusively for charitable, religious, educational, scientific and literary purposes".

CRN is currently the licensee of ten non-commercial educational primary broadcast stations:

- KEXS(AM), Excelsior Springs, Missouri, File No. BML-20061215ACV, granted February 22, 2007.
- KPHN(AM), El Dorado, Kansas, File No. BML-20061215ACW, granted July 12, 2007.
- KEXS-FM, Ravenwood, Missouri, File No. BLED-20080618AAV, granted September 8, 2008.
- KPIO-FM, Pleasanton, Kansas, File No. BLED-20090424AAI, granted May 4, 2009.

- KFEL (AM), Pueblo, Colorado, File No. BML-20061215ACX, granted February 23, 2010.
- KQOH (FM), Marshfield, Missouri, File No. BALED-20121210AAV, granted January 23, 2013.
- KDMR (AM), Kansas City, Missouri, File No. BML-20140606ABH, granted August 29, 2014.
- KMVG (AM), Gladstone, Missouri, File No. BML-20150929APX, granted January 28, 2016.
- KRCN (AM), Longmont, Colorado, File No. BML-20151028AHK, granted April 15, 2016.

Therefore, CRN has been previously approved by the FCC as an entity which is qualified as a non-commercial educational broadcast licensee.

CRN intends to use KKLL for the advancement of an educational program similar to that now ongoing at the ten stations listed above; that is, to broadcast programs to teach the Gospel of Jesus Christ and the Catechism of the Roman Catholic Church.

CRN's programming will consist of the following basic types: (1) "Interactive" programs; (2) recorded programs presented by eminent Roman Catholic professors and scholars

dealing with various topics of the Gospels and Roman Catholic catechism (categories 1 and 2 occupy a majority of the broadcast day); (3) Roman Catholic Masses, the Holy Rosary, Divine Mercy Chaplet and various recitations of seasonal litanies; and (4) newscasts and public affairs programs from a Roman Catholic perspective.

While the exact programs and times will be determined at a future date, a program schedule is attached as illustrative of how CRN intends to advance an educational program. KKLL currently proposes to become an affiliate of the EWTN Global Catholic Radio Network.

In response to FCC Form 340, Section IV, CRN intends to work with local Roman Catholic parishes, catechism programs and organizations to assist their educational efforts with respect to teaching of the Catholic religion; thus, we intend to provide a valuable educational resource for KKLL listeners in the Joplin-Carthage radio market (where Webb City, Missouri is located), to serve the public interest, convenience and necessity and to be in compliance with Section 73.503 of the Commission's Rules.
