

## MARY E. VANDENACK AFFIDAVIT

The undersigned Affiant, upon being first duly sworn and under penalty of perjury personally came and appeared before me and makes her statement and affidavit upon belief and personal knowledge that the following matters, facts and thing set forth are true and correct to the best of her knowledge.

1. Affiant's name is Mary E. Vandenack and she is an attorney in good standing to practice law in the State of Nebraska.
2. Affiant was the attorney for the Karla S. Huse. Affiant prepared her estate plan.
3. Affiant was the attorney for the Eugene Franklin Huse, Jr. Affiant prepared his estate plan.

7. Affiant states that the purpose for this Stock Power was to facilitate business succession and estate planning of Eugene Franklin Huse, Jr. to assure the continuity of WJAG Inc.
8. Affiant declares that this Stock Power was signed by Karla S. Huse on the 1st of March 2017 in the presence of the Affiant who acted and signed as the witness.
9. Affiant further declares that when Karla S. Huse signed this Stock Power, Karla S. Huse was acting under a valid Power of Attorney for Eugene Franklin Huse, Jr.
10. Affiant retained a copy of this executed Stock Power which is attached to this affidavit as Exhibit "A" and incorporated by reference to this Affidavit.
11. Affiant further states that all statements contained in this Affidavit are true.


