BE IT KNOWN, that on this 26th day of May in the year of Our Lord one thousand nine hundred and eighty-eight,

BEFORE ME, M. Chadwick Pellerin, a Notary Public, duly commissioned and qualified, in and for the Parish of Orleans, State of Louisiana, therein residing, and in the presence of the witnesses hereinafter named and undersigned:

PERSONALLY CAME AND APPEARED: Dale Rathke, whose name is hereunto subscribed, of full age, who declares that, availing himself of the benefits and provisions of the Constitution of the State of Louisiana and the laws of said State relative to the organization of non-profit corporations, and particularly to the provisions of R.S. 12:201 *et seq.*, does by these presents form and organize, with all other persons who may hereafter join or become associated with him or his successors, a non-profit Corporation for the objects and purposes and under the covenants, stipulations and agreements following, to wit:

ARTICLE 1. Name.

The name of the corporation is Fifteenth Street Corporation.

ARTICLE 2. Purposes.

Said Corporation is organized to engage in any lawful activity, but exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

The Corporation shall acquire, operate and maintain facilities which can accommodate the offices and programmatic activities of non-profit constituency-based labor, media, and community organizations; organizations which provide services, training, or technical assistance to low- and moderate-income people and their organizations; and community-based business ventures.

ARTICLE 3. Limitations on Corporate Powers.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign for public office.

The Corporation shall not carry on any activities not permitted to be carried on by

- (i) a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law); or
- (ii) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law).

ARTICLE 4. Duration.

The duration of the Corporation shall be perpetual.

ARTICLE 5. Non-profit Corporation.

The Corporation shall be a non-profit corporation.

ARTICLE 6. Registered Office.

The Corporation's registered office shall be located at 1024 Elysian Fields Avenue, New Orleans, Louisiana, 70117.

ARTICLE 7. Registered Agent.

The name and address of the Corporation's registered agent shall be Dale Rathke, 1024 Elysian Fields Avenue, New Orleans, Louisiana, 70117.

ARTICLE 9. Directors; Regular Board, Numbers.

The number of Regular Directors shall be as provided from time to time in the Corporation's By-laws, but shall be at least five.

ARTICLE 10. Directors; Initial Board.

Notwithstanding any provision of Article 9 of these Articles, or any provision of the Corporation's bylaws, the names and addresses of the Initial Board of Directors shall be:

ARTICLE 11. Directors; Term of Initial Board.

The members of the initial Board of Directors shall hold office until the Regular Board, with its members and numbers, and regular officers, are constituted and appointed by the Initial Board through the Articles and By-laws of the Corporation.

ARTICLE 12. Non-stock Corporation.

The Corporation shall be organized on a non-stock basis.

ARTICLE 13. Membership.

The Corporation shall have no members.

ARTICLE 14. Distribution of Earnings.

No part of the net earnings of the Corporation shall inure to the benefit or be distributable to, its Directors, Officers, or other private persons, except that the Corporation shall be authorized and

empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of ARTICLE 2, Purposes, above.

ARTICLE 15. Dissolution.

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for the payment of all the liabilities of the Corporation, dispose of all the assets of the Corporation to such organization or organizations, as the Board shall determine, which organization or organizations shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law). Any assets not so disposed of shall be disposed of by the Circuit Court of the Parish in which the principal office of the Corporation is located, exclusively to such organization or organizations as said Court shall determine.

ARTICLE 16. Amendment of Articles.

These Articles may be amended by a 2/3 vote of the Board of Directors, taken in a manner consistent with procedures set out in the By-laws of the Corporation.

ARTICLE 17. Miscellaneous.

No mere informality in organization shall have the effect of rendering these Articles of Incorporation null, or of exposing the Board of Directors or Officers of this Corporation to any liability other than as provided above.
