Pursuant to 47 CFR Section 73.1690(c)(9), Radio Training Network, Inc. (RTN), hereby notifies the Commission of its desire to operate WALV-FM, Ooltewah, TN (Facility ID No. 66956), as a noncommercial educational station. RTN requests that the Commission grant the instant application upon the grant and consummation of the assignment of license from Brewer Media Group, LLC, to RTN (LMS File No. 0000234795, filed 01/04/2024).

RTN is a tax-exempt entity under section 501(c)(3) of the Internal Revenue Code, organized and operated exclusively for religious, charitable, and educational purposes. In furtherance of its purposes, RTN engages in the production and broadcast of religious and educational programming and such other religious, charitable, and educational activities as determined by its Board of Directors. RTN hereby certifies that the Commission has previously granted numerous broadcast applications that found RTN qualified as a Noncommercial Educational entity with a qualifying educational program (see e.g., BALED-20171212ABM).

RTN seeks to educate, encourage, and inspire the audience in the local community of license with the noncommercial programming it produces and broadcasts. In addition to featuring inspirational music, RTN offers programming examining religious, social, and economic issues and current events. These include programs on Bible teachings, marriage and family, financial management, and helping listeners learn how they can get involved in meeting needs both locally and around the world. Additionally, RTN connects its listeners to their local community through a Family Calendar where local events are posted, a Job Board listing job openings, and a “Find a Church” feature to help listeners connect with local churches.

WALV-FM will be used to advance a program similar to that which the Commission has found qualifying in previous applications. WALV-FM will further RTN’s purposes by providing religious and educational programming designed to meet the needs and interests of the local community of license.
