

**Abstract of the Fahnoe Family Trust**

The following trust abstract is being provided for Assignee, the Fahnoe Family Trust (the "Trust") pursuant to Section 73.3613(b)(3)(iii) of the Commission's rules:

1. **Name of the Trust:** The Fahnoe Family Trust
2. **Grantors, Trustees, and Beneficiaries of the Trust:** The Trustees, Beneficiaries, and Grantors are the same persons: Eric D. Fahnoe and Michelle Fahnoe.
3. **Duration of the Trust:** The Trust will terminate after the death of the last contingent beneficiary or at the time as allowed by California law.
4. **Percentage of Stock Owned:** Upon the completion of the transfer of control proposed in the instant application, the Trust will hold 100% of the stock in licensee, the Dimes Media Corporation ("Dimes Media").
5. **Names of the Parties who have the Power to Vote or Control the Vote of the Stock:** Eric D. Fahnoe and Michelle Fahnoe
6. **Any Conditions on the Powers of Voting the Stock or any Unusual Characteristics of the Trust:** Any sale, purchase, transfer, or encumbrance of real estate or shares in Dimes Media or its broadcast licenses requires the signature of both trustees, Eric D. Fahnoe and Michelle Fahnoe, so long as both are competent and living and neither has resigned as trustee. Up the death, resignation, or incapacity of either Eric D. Fahnoe or Michelle Fahnoe, the other trustee shall have authority to execute any contract, agreement, or other document effecting a sale, purchase, transfer, or encumbrance of real estate or shares in Dimes Media.
7. **Persons with Power to Sell Stock Held in the Trust:** Eric D. Fahnoe and Michelle Fahnoe
8. **Persons with Power to Replace Trustee at Will:** None.
9. **Persons with Power to Revoke the Trust:** The Trust may be jointly revoked by the trustees, Eric D. Fahnoe and Michelle Fahnoe. After the death of either Eric D. Fahnoe or Michelle Fahnoe, the sole surviving trustee may amend or revoke the Trust in whole or in part at any time during his or her life. If a trustee is incapacitated and unable to make decisions, the incapacitated trustee's agent under the incapacitated trustee's power of attorney, or the incapacitated trustee's conservator, may not amend or revoke the Trust on the incapacitated trustee's behalf – except to add special needs provisions for the incapacitated trustee's benefit. Any trustee who retains capacity also retains the right to amend the Trust should the other trustee have lost capacity.

# The Declaration of THE FAHNOE FAMILY TRUST

## FACE PAGE SUMMARY

**Name and Type of Trust:** THE FAHNOE FAMILY TRUST, is a Trust established January 18, 2024, which is Revocable & Amendable during the Settlers' Joint-Lives.

**Settlers, Trustors & Grantors:** ERIC DIMES FAHNOE and MICHELLE FAHNOE

**The Initial Trustees:** ERIC DIMES FAHNOE and MICHELLE FAHNOE

**Authorizations for Signing Documents:** Either Trustee is authorized to sign any contract or agreement, make any purchase, or sell or give away any asset, EXCEPT that any sale, purchase, transfer, or encumbrance of real estate or shares in Dimes Media Corporation & Broadcast Licenses requires the signature of BOTH Initial Trustees, so long as both are competent and living and neither has resigned as Trustee. Upon the death, resignation or incapacity of an Initial Trustee (each of whom is a Settlor of the Trust) the Trustee who is a Settlor still acting as Trustee shall have authority on his or on her individual signature to execute any contract, agreement or other document effecting a sale, purchase, transfer or encumbrance of real estate or shares in Dimes Media Corporation. Following the death of the Surviving Settlor, a Successor Trustee who is a sole Trustee of the Trust shall have the sole authority to execute any contract, agreement or other document effecting a sale, purchase, transfer or encumbrance of real estate or shares in Dimes Media Corporation. Federal F.C.C. approval may also be required.

### **Successor Trustees:**

Upon the death, resignation or incapacity of *either* ERIC DIMES FAHNOE or of MICHELLE FAHNOE, **the other initial Trustee has power to act as sole Trustee** with all the powers of the original Co-Trustees.

Upon the death, resignation or incapacity of *both* ERIC DIMES FAHNOE and MICHELLE FAHNOE, the following are appointed as the sole Successor Trustee in the order that they are named:

1<sup>ST</sup> Successor Trustee: PATRICIA ANN FAHNOE JAY, born November 22, 1971;

2<sup>nd</sup> Successor Trustee: COULTER DIMES JAY, born August 27, 2007.
