**Informal Objection**

Dear Applicant and Objector:

We have before us the above-referenced application (Modification Application) for a minor modification to the licensed facilities of station KHTW(AM), Lumberton, Texas (Station or KHTW), filed by previous licensee Carlos Lopez (Lopez) on October 13, 2023, and prosecuted by current licensee Darby Ventures, LLC (Darby).<sup>1</sup> We also have an informal objection (Objection) to the Modification Application, filed by SouthEast Texas Telecom (STT) on November 11, 2023.<sup>2</sup> For the reasons set forth below, we deny the Objection and grant the Modification Application.

**Background.** The Modification Application seeks to modify the Station's license to reduce KHTW's licensed operating power, downgrade from a Class B to Class D station, and broadcast omnidirectionally from a single tower rather than a three-tower directional array.<sup>3</sup> In the Objection, STT claims that the proposed modification will reduce the Station's coverage area by over one half of the population of Hardin County, Texas,<sup>4</sup> and leave the Station vulnerable to co-channel interference from other stations.<sup>5</sup> STT also alleges that, on October 27, 2023, Lopez improperly removed two of the four KHTW towers after filing a request for special temporary authorization (STA Request) but before the

STA Request had been granted.<sup>6</sup> STT states that legal action is pending in the Hardin County court to return the license, transmitter site, and equipment to STT, and that the dismantling of the towers will cause STT financial hardship to return the Station to its previous condition if it prevails in court.<sup>7</sup> Therefore, STT asks that the Application be denied and the Station ordered back to its full licensed power and operation.<sup>8</sup>

**Discussion.** Pursuant to section 309(e) of the Communications Act of 1934, as amended,<sup>9</sup> an informal objection, like a petition to deny, must contain specific allegations of fact sufficient to show that grant of the application would be prima facie inconsistent with the public interest, convenience, and necessity.<sup>10</sup> These allegations of fact, except for those of which official notice may be taken, must be supported by an affidavit or declaration under penalty of perjury of someone with personal knowledge of the facts alleged.<sup>11</sup> The Objection does not meet this standard.

STT cites to no rule or precedent supporting its argument that the Commission should order Darby to continue to serve its currently licensed coverage area with a full directional array despite the financial and technical obstacles to doing so, as set out in this and earlier proceedings.<sup>12</sup> Our engineering review indicates that the proposed operation will not cause or receive impermissible predicted interference to or from any other broadcast station. We find that the facility modifications allegedly carried out in October 2023 were in accordance with the STA granted on June 30, 2023.<sup>13</sup> Finally, regarding the proceedings in state court, as we explained in the *Assignment Letter*, any Commission action based on this ongoing private contractual dispute would be inappropriate absent an injunction or final court determination.<sup>14</sup> Grant of the Modification Application is permissive in nature and does not prejudice any relief to which the parties may ultimately be entitled under the civil suit.<sup>15</sup>

**Conclusion/Actions.** For the reasons stated above, IT IS ORDERED that the informal objection filed by SouthEast Texas Telecom (STT) on November 11, 2023, IS DENIED and the application for a
