Additionally, the 2021 Children's Television Programming Report was filed a day late, because of an error in calculating the filing date.

It is the station's policy to upload new and revised orders to its political file as soon as possible once an order or change has been accepted and processed. During periods of especially

high activity, some political file updates may be delayed, particularly with respect to information revising ongoing orders or reconciling completed orders. Station personnel are available to answer questions from the public regarding any revision or reconciliation information not yet reflected in the station's political file. An internal audit of the station's political file, which was conducted in connection with the preparation of this renewal application, identified 15 orders placed in 2020 and 2021 that were missing from the political file – which were uploaded once identified in the audit – and one order that was uploaded to the political file more than seven days after being placed. The station has established additional procedures to ensure that the political file is complete and timely updated.
