Extension of Experimental Authority for a Radio Broadcast Station

Audio Division, Media Bureau

An extension of the Experimental Authority granted March 26, 2019 under file number 20190226AAV, is **GRANTED**, subject to all the terms and conditions specified in the original Experimental authorization. The licensee is responsible for addressing any complaints of interference that may arise.

This extended authority expires **March 26, 2024**.

Considerations:

We note that the operation does not comply with the contour non-overlap requirement pursuant to the Media Bureau's Order adopted January 27, 2010, in MM Docket No. 99-325. Specifically, WGPU-FM's 49.5dBu F(50,10) contour would overlap with the 60dBu F(50,50) protected contour of the first adjacent station WBGY, Naples, FL, in the upper sideband. Operation under this authority shall be terminated if complaints of interference are received, unless the interference can be eliminated immediately by power reduction or other means.

Licensee must take all steps to ensure that workers and the public are not exposed to radiofrequency exposure in excess of the Commission's exposure limit.

This Experimental Authority does not supersede any non-FCC-regulated requirements applicable to the STA-authorized facility. The licensee remains solely and wholly responsible for maintaining compliance with such requirements.

Pursuant to Section 5.71(c) of the Commission's rules, a broadcast experimental authorization is issued for a one year period and may be renewed for an additional term not exceeding five years upon an adequate showing of need. Upon expiration of this experimental authority, WGPU-FM's experimental operation using asymmetric digital sideband powers will have reached the five year renewal limit set forth in Section 5.71(c), and no further renewals of this authority will be granted.
