DECREE ADMITTING WILL TO PROBATE
AND GRANTING LETTERS TESTAMENTARY

PRESENT HONORABLE William A. Tate, JUDGE OF PROBATE:

This day came Oma Jean Dudley who has delivered to this Court instruments purporting to be the Last Will and Testament of Asa E. Dudley, Jr., deceased, together with her petition in writing and under oath for the probate thereof and for Letters Testamentary to be issued to said petitioner, without bond, as provided in said Will;

And it appearing to the satisfaction of the Court, from said sworn petition and from the evidence presented in this cause, that all of the heirs at law and next of kin are listed on the Petition for Probate of Will and Letters Testamentary, are each over the age of nineteen years and of sound mind and have either signed waivers of notice of the date of probate or have been served with notice of the hearing in this cause; now the court proceeds to hear said petition.

And it further appearing to the satisfaction of the Court that the Will of Asa E. Dudley, Jr., deceased, was executed by said decedent, late an inhabitant of this County; that said decedent signed and executed said Will on the day the same bears date in the presence of two witnesses, and declared the same to be his Last Will and Testament; that the said witnesses set their signatures thereto in the presence of said decedent, at his request, and in the presence of each other; and that said decedent was over the age of nineteen years, of sound mind and disposing memory, and in the opinion of said affiants, fully capable of making his said Will at the time the same were so made as aforesaid.

And the Court, having heard the evidence offered for and against the granting of the said petition, is of the opinion that the relief prayed for in said petition should be granted.


And it further appearing to the Court that Oma Jean Dudley is named in said Will as Executrix thereof, is expressly exempted from making bond therefor, and is fully qualified in the judgment of the Court to serve in such capacity.

IT IS, THEREFORE, ORDERED, ADJUDGED and DECREED by the Court that said Will of Asa E. Dudley, Jr., deceased, be received and hereby declared to be duly proved as the Last Will and Testament of said decedent and, as such, admitted to probate and ordered to be recorded, together with all other papers on file relating to this proceeding;

IT IS, FURTHER, ORDERED, ADJUDGED and DECREED by the Court that the said Petitioner, Oma Jean Dudley, be and is hereby appointed Executrix of the Will of said decedent, and that Letters Testamentary issue forthwith to the said Oma Jean Dudley without bond, as expressly provided in said Will.

IT IS, FURTHER, ORDERED that said Executrix pay the costs of this proceeding, for which she shall be reimbursed from said estate.
