Bluff Country Community Radio is acquiring AM radio station KFIL, currently licensed to Townsquare License, LLC. KFIL is currently a for-profit, commercial AM broadcast service in Preston, Minnesota. Alongside this acquisition, KFIL will convert to noncommercial status.

Bluff Country Community Radio is a non-profit organization exempt from income tax under Section 501(c)(3) of the Internal Revenue Code. Bluff Country Community Radio will operate as a non-profit, non-commercial broadcast service to serve the Preston, Minnesota and Filmore County area for the advancement of educational programs for the community. Bluff Country Community Radio plans to transmit educational, cultural, entertainment, and religious programs to the public, that align with our mission to:

- (1) keep listeners informed with quality, community-based programming with an emphasis on local issues and events coverage;
- (2) foster discussion of current political trends and social issues, news, sports, and information;
- (3) bring together the people of southeast Minnesota through radio programs and live events that are otherwise unavailable in the rural area the station serves; and
- (4) improve the quality of life and provide positive experiences for community residents, through entertainment, public service announcements, and forums for discussing issues that affect their lives.
