Agreements: The transfers of control proposed herein are pursuant to the administration of the Robert J. Ingstad Estate. Stacy L. Ingstad is Robert J. Ingstad’s widow and the personal representative of the Estate. There are no written agreements to submit to the Commission.

Multiple Ownership: Stacy L. Ingstad is assuming the existing interests of her late husband in this application. There is no change in the multiple ownership analysis and thus, no studies are necessary in connection with these applications. Except as noted herein, Stacy L. Ingstad holds no other broadcast interests.

Other Authorizations: Robert J. Ingstad (deceased) also held a non-controlling 33.3% interest in FCC licensees, i3G Media, Inc., i3G Media, LLC and i3G Radio, LLC. Those interests have been assigned to his widow Stacy L. Ingstad (30.3%) and their daughter, Reagan Ingstad (3%).
