Informal Objection

Dear Applicant and Objector:

We have before us the above-referenced application (Application) for a construction permit for a new low power FM (LPFM) station at Omaha, Nebraska, filed by North Sun Media Broadcasting (North Sun) on December 15, 2023. We also have before us an Informal Objection (Objection) to the Application, filed by REC Networks (REC) on January 24, 2024.¹ For the reasons set forth below, we grant the Objection and dismiss the Application.

Background. North Sun filed the Application on December 15, 2023, during the 2023 LPFM filing window.² North Sun certifies in its Application that it is a nonprofit educational institution or organization³ eligible for an LPFM authorization and includes a one-page exhibit, stating that “[w]e are a non-profit organization driven by the belief that every voice matters...”⁴

REC alleges that North Sun is not qualified for an LPFM license.⁵ Specifically, REC asserts that North Sun neglected to submit any documentation to establish that it is either a valid nonprofit educational organization or unincorporated association recognized under state law.⁶ REC notes that a search of the Nebraska Secretary of State database shows no corporation with the name “North Sun” in it,⁷ and that absent any legal recognition by any state, North Sun is not qualified to hold an LPFM license.⁸ REC, therefore, urges the Commission to dismiss the Application.

Discussion. Pursuant to section 309(d) of the Communications Act of 1934, as amended (Act),⁹ petitions to deny and informal objections must provide properly supported allegations of fact that, if true, would establish a substantial and material question of fact that grant of the application would be *prima facie* inconsistent with the public interest.¹⁰ We find that REC has met this burden.

An LPFM applicant must meet basic eligibility requirements¹¹ and certify its eligibility to own and operate an LPFM station at the time that it files its FCC Form 2100, Schedule 318 application.¹² Specifically, each applicant claiming eligibility as a nonprofit educational organization must certify it is a noncommercial educational institution, corporation, foundation, association, or entity that is recognized under state law at the time the application is submitted.¹³ Each applicant must also submit an explanatory exhibit, establishing its nonprofit status, in connection with its application.¹⁴

In its Application, North Sun certified that it is a nonprofit educational organization, but initially neglected to provide any supporting documentation, as required, to establish its nonprofit status. On February 23, 2024, North Sun amended its Application to include a copy of its Articles of Incorporation.¹⁵ According to the state stamp from the Nebraska Secretary of State, however, North Sun did not file its

Articles of Incorporation until February 1, 2024. A review of the Nebraska Secretary of State database of corporations confirms that North Sun was not incorporated until February 1, 2024, over a month after it filed its LPFM Application. Accordingly, because North Sun was not incorporated, nor demonstrated that it was organized in a form recognized by Nebraska state law, on December 15, 2023, when it submitted its Application, we find North Sun ineligible to hold an LPFM license and dismiss the Application.¹⁶

Conclusion/Action. Accordingly, **IT IS ORDERED** that the Informal Objection filed by REC Networks on January 24, 2024, (Pleading File No. 0000236235) **IS GRANTED**.

IT IS FURTHER ORDERED that the application of North Sun Media Broadcasting for a construction permit for a new low power FM station at Omaha, Nebraska (Application File No. 0000233064) **IS DISMISSED**.
