Purpose of Application & Technical Statement

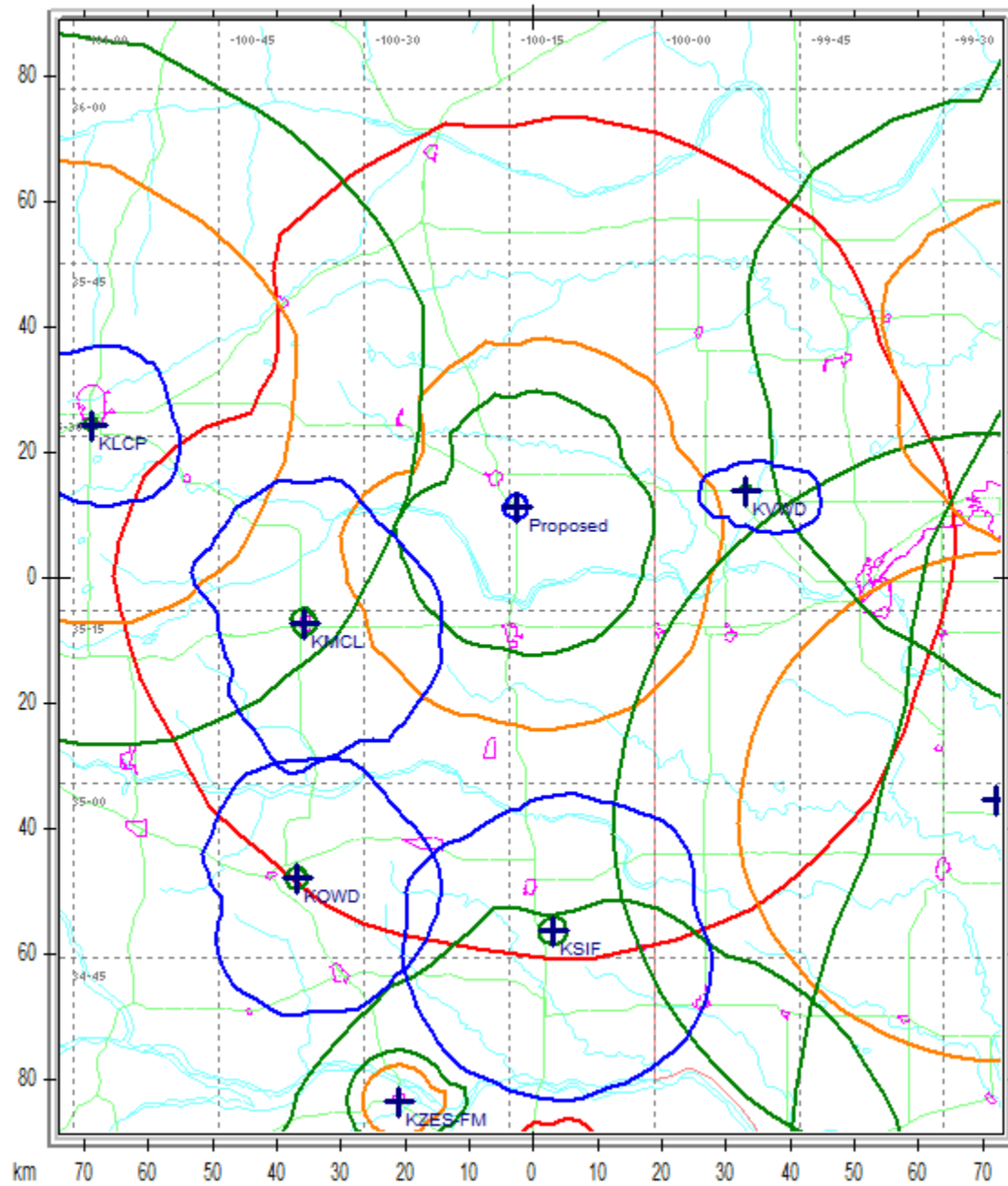

The application herein requests a non-adjacent channel change from Channel 202-A to Channel 216-A. This is a minor change, in-class modification, Per MB Docket No. 05-210, RM-10960 Paragraph 16, allowing existing commercial and non-commercial licensees are permittees to request Rule Making Proposals and Allotment Petitions as a part of the electronic FCC filing process, with the requested "channel substitutions for authorized facilities being treated as "minor" changes".
