## **Request for Special Temporary Authorization**

TV Translator Station K38AK-D, Ponca City, OK (Facility ID 50203)

Pursuant to *Incentive Auction Task Force and Media Bureau Set Forth Tools Available to LPTV/Translator Stations Displaced Prior to the Special Displacement Window* Public Notice, DA 17-584, MB Docket No. 16-306, GN Docket No. 12-268 (June 14, 2017), and Sections 74.780 and 73.1635 of the FCC's Rules, Oklahoma Educational Television Authority Commission ("OETA"), licensee of noncommercial educational TV translator Station K38AK-D, Ponca City, Oklahoma, respectfully requests Special Temporary Authorization ("STA") to operate the station in accordance with the technical parameters proposed in its pending channel 28 displacement permit application in FCC File No. 0000029429 (copy attached).

OETA filed the channel 28 displacement modification application to seek relief for K38AK-D following receipt of a notification letter from T-Mobile regarding its planned use of the 600 MHz band (copy attached). T-Mobile's letter indicates that it will commence its operations in the K38AK-D market by October 31, 2017 and that K38AK-D is likely to cause harmful interference to T-Mobile's operations. In the June 14, 2017 Public Notice referenced above, the FCC set forth tools for use by TV translators such as K38AK-D displaced by 600 MHz band wireless operations, including the filing of a displacement permit application/freeze waiver¹ accompanied by an STA application.

In accordance with those procedures, OETA now seeks STA to operate its Ponca City, Oklahoma TV translator on channel 28 as proposed in the recent displacement application and while that application remains pending in anticipation of the Special Displacement Window.<sup>2</sup> The attached displacement application in File No. 0000029429 demonstrates that the proposed channel 28 facility complies with the FCC's technical and interference rules.

NET respectfully submits that a grant of STA will serve the public interest by allowing the continued operation of K38AK-D on its newly proposed and available channel despite the station's displacement from its licensed channel due to the impending 600 MHz band wireless operations in its area. OETA is a governmental entity and a noncommercial educational licensee and operates K38AK-D on a noncommercial educational basis.
