Detailed responses to the Construction Permit Certification questions:

* It will operate on the DTV channel for this station as established in the post-incentive auction channel reassignment public notice. **(No) See Unable to Construct Channel Resolution Agreement**

* It will operate post-incentive auction facilities that do not expand the noise-limited service contour in any direction beyond that established by the post-incentive auction channel reassignment public notice. **(No) Applicant proposes to expand its noise limited contour.**

* It will operate post-incentive auction facilities that match or reduce by no more than five percent with respect to predicted population from those defined in the post-incentive auction channel reassignment public notice. **(No) Applicant is proposing to expand, not reduce, its population coverage.**

* The antenna structure to be used by this facility has been registered by the Commission and will not require reregistration to support the proposed antenna, OR the FAA has previously determined that the proposed structure will not adversely affect safety in air navigation and this structure qualifies for later registration under the Commission's phased registration plan, OR the proposed installation on this structure does not require notification to the FAA pursuant to 47 C.F.R. Section 17.7. **(Yes)**
