

Request for Extension of Construction Permit

KXTV, LLC ("KXTV"), hereby requests an extension of the expiration date for its construction permit for a new digital replacement translator, File Number BDRTCDT-20140317ACA. The permit is scheduled to expire on March 29, 2018. KXTV seeks a six-month extension of the construction deadline, to September 29, 2018.

As previously stated, KXTV needed to complete a tower survey to confirm that the proposed tower would support the antenna and feed line before construction plans could be made. That survey has been completed. The construction plans have been made and the project is being funded. However, the equipment cannot be delivered and installed before the current construction period expires on March 29, 2018.

Therefore, KXTV, LLC requests a six-month extension of time in which to complete construction.
