Summary

Beach TV Properties, Inc. ("BTVP") will be dismantling its current TV tower and relocating to a new tower site authorized to sister station WPCT TV in file number 0000034180. The proposed site is 0.14 kilometers from the licensed site. No change in RC AGL, AMSL, antenna pattern, channel or ERP are proposed. The site has been studied by the FAA, study number 2017-ASO-17486-OE and a No Hazard Determination was issued on October 4, 2017. The proposed tower is 78 meters (256') AGL with appurtenances. The proposed antenna is a horizontally polarized, slot type, with a horizontal plane radiation pattern equal to the licensed antenna. At this site and RC AMSL of 50 meters the proposed ERP is 15 Kw. The entire community boundary of Panama City, Florida is located well inside the city grade contour.

Attached herein is the TVStudy version 2.2.5 output which demonstrates that the proposed facility will cause no interference to any station and the received interference is less than 0.5% of the baseline population.

Environmental

The proposed antenna system is a SWR model SWLP8PNSP, horizontally polarized, UHF, slot type, TV antenna. The radiation center is 45 meters above ground. Utilizing formula 10 OF OET Bulletin No. 65, Edition 97-01, a value F of 0.2 has been used to calculate the power density 2 meters above ground. The maximum power density is 10.8 microwatts/cm squared calculated for an ERP of 15,000 watts H. polarization. This value is 3.14% of the General Population exposure per section 1.1310. Based on this analysis it is believed that the proposed facility follows OET-65 Guidelines.

The applicant will reduce power or cease transmission as required to meet FCC OET-65 Worker Safety Guidelines.

AM Station Protection

Non-Directional AM Station WPCF(AM) 1290 kHz operates from a tower located 0.32 kilometers from the proposed tower which has an electrical height of 117.96 degrees at 1290 kHz. CFR 1.30002 requires in part that *Proponents of construction or significant modification of a tower which is within one wavelength of a nondirectional AM station, and is taller than 60 electrical degrees at the AM frequency... shall examine the potential effects thereof using a moment method analysis. The moment method analysis shall consist of a model of the AM antenna together with the potential re-radiating tower in a lossless environment. Should the construction or modification distort the radiation pattern by more than 2 dB, the proponent shall be responsible for the installation and maintenance of any detuning apparatus necessary to restore proper operation of the nondirectional antenna.*

A Moment Method analysis of the proposed structure and its predicted impact on the AM station has been conducted. The calculating engine used was the Numerical Electromagnetics Code version 4.2. The model was calculated over perfect ground. The coordinates for the AM station were taken from Google Earth Professional, and the coordinates provided by the proponent of the proposed structure were used. The calculated distortion is 56.5% of the 2 dB limit and thus detuning is not required. BTVP will notify the licensee of WPCF as per CFR 1.30004.
