## **APPLICATION FOR CONSTRUCTION PERMIT - DISPLACEMENT**

The following engineering statement and attached exhibits have been prepared for **Digital Networks-Southeast, LLC** ("Southeast"), permittee of digital low power television station W41EL-D at Eufaula, Alabama, and are in support of their application for construction permit for displacement. This application addresses the displacement of the existing construction permit under FCC File No. BDCCDTL-20120718ACP, and changes the community of license to Columbus, Georgia.<sup>1</sup>

The current construction permit for W41EL-D authorizes operation as a digital low power station on channel 41. The authorized facility would operate with a maximum effective radiated power of 1 kW at a center of radiation of 248 meters above mean sea level utilizing a directional antenna. The proposed facility would operate on channel 20 as digital low power facility with a maximum effective radiated power of 1.7 kW at a center of radiation of 177.5 meters AMSL. The antenna proposed for use is a Kathrein-Scala PR-TV array consisting of two elements. One is oriented at 30 degrees true with the other at 210 degrees true.<sup>2</sup> This array does not specify the use of beamtilt.

The technical parameters for this application propose the use of the current authorized site. This, therefore, represents a minor change to the existing construction permit. Exhibit E-1 makes a comparison between the licensed analog facility, the authorized digital facility, and the proposed facility. As this map demonstrates, contour overlap exists between the authorized and proposed

facilities, and the proposed technical parameters are located within 30 miles of the licensed analog site.

Exhibit E-2 is the output from *TVStudy* for the proposed operation. This study demonstrates that there are no outgoing IX check failures to any proposed or authorized facility except for the license for WCOV-TV at Montgomery, Alabama.<sup>3</sup> WCOV-TV is assigned to phase 5 of the repack. Southeast respectfully requests a waiver of Section 73.3517 of the Commission's Rules, if necessary, as this application is contingent on the cessation of operation by WCOV-TV on channel 20. A grant of this application would be in the public interest as it will permit W41EL to serve its viewers on a new channel within the repacked core. Southeast agrees to the placement of a condition on the construction permit that operations on channel 20 cannot commence until such time as WCOV-TV commences operation on channel 22.

The proposed facility would not constitute a significant environmental impact, and is exempt from environmental processing. The proposed antenna would be mounted to an existing tower that is registered with the Commission. The addition of the antenna to this tower would not increase the already existing environmental impact present from the tower.

In addition, the proposed facility would not result in human exposure at ground level to radiofrequency radiation in excess of the Commission's safety standards. Using the equations in Supplement A of *OET Bulletin 65*, the calculated worst-case power density at ground level assuming a downward radiation relative field of 0.3 is  $1.79 \mu\text{W}/\text{cm}^2$ . This value is substantially below the upper limit of the uncontrolled environment condition. Southeast certifies it will

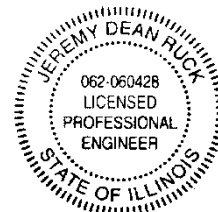

coordinate with all other users of the site to ensure that workers and other personnel are not exposed to levels of radiofrequency radiation in excess of the applicable safety standards. Coordination activities will include, but are not necessarily limited to, a reduction in transmitter power or cessation of operation.

The proposed facility complies with the provisions of Section 74.709 of the Commission's Rules. No land mobile protection issues have been identified based on the tables in that section of the rules, or on the output of *TVStudy*. The proposed facility also complies with Sections 74.793(e)-(h) and 74.793(h) of the Commission's Rules, unless waived as was previously discussed in this text.

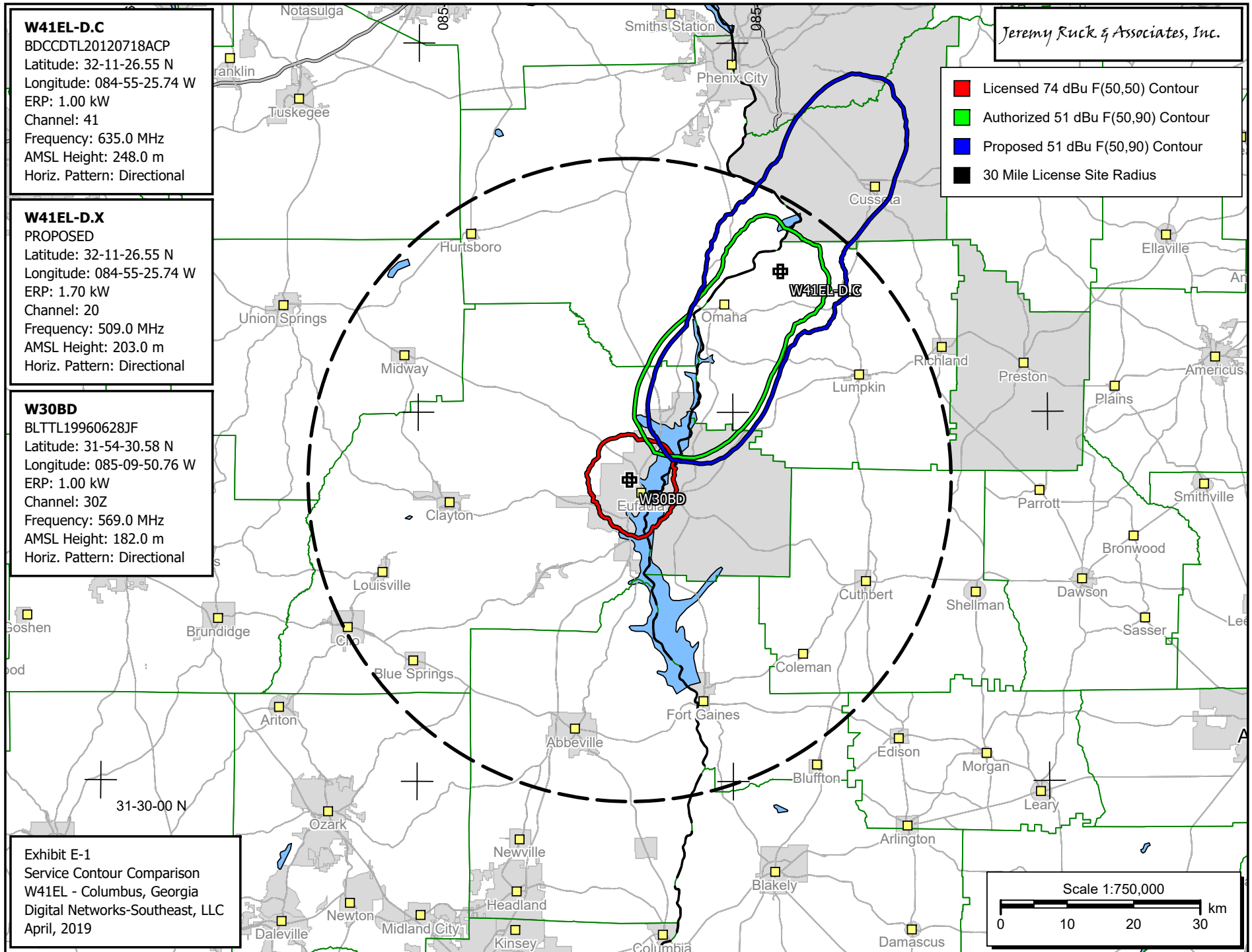
