#### REASON FOR LEGAL SPECIAL TEMPORARY AUTHORITY

This application requests a transfer of WVIR-TV from Transition **Phase 5** to **Phase 6** in the post-incentive auction repack of the television spectrum.

WVIR-TV is moving from Channel 32 to Channel 2. It is currently assigned to Phase 5, with a construction completion deadline of September 6, 2019. A delay until Phase 6 is requested, with a completion deadline of October 18, 2019.

#### Unexpected Equipment Delivery Delays

The licensee requires a new transmitter and antenna and is replacing an existing tower, all as authorized in LMS File No. 0000034904. The tower construction will be completed on time. The new transmitter, antenna, and associated equipment were ordered in January of 2019, with delivery promised in time to complete construction in August. The licensee believes that the ordering lead time was ample.

Then, on July 25 and July 26, the licensee unexpectedly received letters from Jampro, stating that it would be 8 more weeks before delivery of the antenna, and from Hitachi Koksusai Comark, stating that delivery of the transmitter would be delayed for 2 weeks. Comark sent a second letter, on August 7, stating that delivery will be delayed for 3 weeks. These unexpected delays make it impossible to complete construction of the new Channel 2 facilities by September 6.

The timely equipment orders and unexpected delay notifications are documented by the attached excerpts from the equipment orders and letters from the suppliers, stating that delivery deadlines will not be met. (The terms of the Comark order were agreed upon in January; the order is dated March-April only because of delays in completing the associated paper work.) WVIR-TV has made all required payments, so delivery delays are not based on any payment delinquencies.

As of the date of this request, the Comark transmitter has been shipped, with arrival anticipated during the week of August 19-23. Jampro has still not provided a firm new delivery date, despite repeated requests and daily telephone calls. The licensee has emphasized to Jampro that the new antenna must arrive in time to be in service no later than October 18, 2019, the end of Phase 6. The licensee has kept the tower rigging crew informed about the delay and believes that the tower crew will be able to meet the October 18 deadline.

A waiver to place WVIR-TV in Phase 6 will establish a revised deadline of October 18, 2019, for operation on Channel 2 under program test authority to commence. Absent further unanticipated equipment delivery delays or unusual prolonged bad weather, WVIR-TV believes that it can meet that deadline.

### Engineering Analysis – No Adverse Impact on Other Stations

Two other stations are linked to WVIR-TV's channel change, for a total of 3 stations:

Both WCAV-TV and WZBJ-CD are licensed to Gray Television Licensee, LLC; so only two licensees are involved.

As can be seen from the above list, WCAV-TV will take over WVIR-TV's channel, and WZBJ-CD will take over WCAV-TV's channel. The only new channel being introduced that is not already in use in the area is Channel 2. WVIR-TV believes that based on the Commission's TV Query web page, the closest Channel 2 facility is a granted, but unbuilt, displacement construction permit for WNDC-LD, FID 130443, Salisbury, MD, approximately 248 km away; but WNDC-LD holds a superseding construction permit for displacement relief to move to Channel 17 rather than Channel 2. The nearest primary service stations on Channel 2 are further away and are already licensed, with none having to change channel to make room for WVIR-TV.

Gray Television Licensee, LLC will be filing its own separate Legal STA request to move both WCAV-TV and WZBJ-CD to Phase 6.

### Consumer Education – MVPDs

In Phase 5, on-air PSAs or crawls were to begin on August 7, 2019, to inform the public of the channel change. Those announcements will now be started on September 18, 2019, 30 days before the Phase 6 cutover date. Because WVIR-TV and WCAV-TV are the only two full service television stations in Charlottesville, and they will both move to their new channels on the same date, it is anticipated that the Phase change will not cause public confusion. The third station in Charlottesville is WHTJ, which shares a channel and is not scheduled not transition until Phase 8; so its transition date will be separate from WVIR-TV and WCAV-TV in any event. Nevertheless, WVIR-TV will broadcast a double schedule of at least 120 seconds per day of PSAs and/or crawls instead of the otherwise applicable 60-second requirement.

MVPDs have already been notified of the channel change. Supplemental notices will be sent advising all MVPDs of the date change.

### Conclusion

In light of the foregoing, Virginia Broadcasting, LLC respectfully submits that a Phase waiver is justified, because the equipment delivery delays are last-minute and beyond its control; the delays are not the licensee's fault, because it ordered and has paid for equipment in a timely manner; and no station beyond the three stations that are all requesting the same Phase waiver will be adversely affected.


