

## Online Public Inspection File

WHLG(FM), 101.3 MHz, Port St. Lucie, Florida, Facility Id No. 27674 (the "Station") was the subject of a "long-form" transfer of control approved via Form 315 that was consummated as of August 26, 2013. See FCC File No. BTCH-20130529ARA. Consequently, the certifications and responses in this renewal application are based on the period starting on August 26, 2013 through to the present. See INSTRUCTIONS – FORM 2100, SCHEDULE FCC 303-S – RENEWAL OF BROADCAST STATION LICENSE (March 2019 edition) ("if the station license was assigned or transferred during the subject license pursuant to a 'long-form' application on FCC Form 314 or 315... the renewal applicant's certifications should cover only the period during which the renewal applicant held the station's license.").

As a "radio station not in the top 50 Nielsen Audio markets" or as a "radio station with fewer than five full-time employees," the Station was not required to transition to its online public inspection file until March 1, 2018. See 47 C.F.R. Section 73.3526(b)(2)(i).

Note the following regarding the "No" response to this certification: "Licensee certifies that the documentation required by 47 C.F.R. Section 73.3526 or 73.3527, as applicable, has been uploaded to the station's public inspection file as and when required."

For public file documents generated before the online transition date, the Licensee uploaded the required documentation to the Station's online public inspection file on or before March 1, 2018, with the following exceptions:

- The FCC online system reports that, generally, the then-existing Station's Quarterly Issues/Programs Lists were uploaded on March 30, 2018. However, folders for these reports were created on February 27, 2018, but under FCC Authorizations/Additional Documents, and the Licensee had uploaded the then-existing Quarterly Issues/Programs Lists prior to March 1, 2018 to those folders. It is believed that the FCC online system is reporting upload dates of March 30, 2018 as that is the date when the previously-uploaded Quarterly Issues/Programs Lists were relocated by the Licensee to the Issues and Program Lists folders (by deleting from the prior folders and then uploading to the new folders). It is noted that for some quarters, supplemental details as to the times of broadcast on the Station of the two "long form" public interest programs were uploaded to the online public file on May 7, 2018.
- The Station's online public file materials for the Quarterly Issues/Programs Lists for the 3<sup>rd</sup> Quarter 2013 and 4<sup>th</sup> Quarter 2014, which specified the times of broadcast on the Station, were recently supplemented with details as to the issues and topics covered by the two "long form" public interest programs.
- The 2016-2017 Annual EEO Public File Report was uploaded on February 27, 2018, however, certain of the Station's pre-existing Annual EEO Public File Reports were not uploaded until April 9, 2018.
