

Multicast Disclosure

Tribune Media Company (“Tribune”), licensee of KRCW-TV, Salem, Oregon, (Fac. Id. No. 10192), RF Channel 33 proposes to: (1) transition its current primary ATSC 1.0 – 33.1 CW programming to host station KATU(TV), Portland, Oregon (Fac Id. No. 21649), RF Channel 24, licensed to Sinclair Portland Licensee, LLC, (2) transition its ATSC 1.0 – 33.2 AntennaTV, ATSC 1.0 – 33.3 Court TV and ATSC 1.0 -- 33.4 TBD programming to commonly owned station KOIN-TV, Portland, Oregon (Fac. ID 35380), RF Channel 25, and (3) commence ATSC 3.0 operations from its current facility. To comply with Commission requirements, applications for KATU(TV) and KOIN-TV to be the 1.0 host stations for KRCW-TV are being filed contemporaneously with this application.

In order to ensure no loss of over-the-air programming to the general public, Tribune will transition these program streams as noted above but will maintain the PSIP virtual channels for those streams pursuant to Annex B.1.7 of ATSC A/321:2016 (as incorporated in the Commission’s rules in Section 73.8000). Pursuant to that certain Ex Parte Notice of the National Association of Broadcasters dated January 27, 2020,¹ Nexstar respectfully requests that such virtual channel mapping appear on the face of any license(s) that result from the instant application.²

For clarity, KRCW’s multicast channels will be hosted in 1.0 as follows:

In turn, Nexstar’s KRCW-TV will provide ATSC 3.0 lighthouse service to KATU-

TV, Portland, Oregon (Fac. Id. No. 21649), licensed to Sinclair Broadcast Group, Inc., and commonly owned station KOIN-TV, Portland, Oregon (Fac. Id. No. 35380) and may also provide ATSC 3.0 lighthouse service to an additional station or stations.

In addition, and in an abundance of caution, Tribune is filing contemporaneously herewith a legal request for Special Temporary Authority to effectuate the license notation requested herein for KRCW-TV.
