Cartier Communications, Inc. ("Cartier") wishes to relocate WYUL (FM). Because Cartier owns other stations in the area, a Multiple Ownership Compliance Study is required to be certain the proposed relocation is in compliance with Section 73.3555 of the Commission's rules.

Cartier owns the following stations:

WICY (AM)	Malone, NY	1490 kHz
WVNV (FM)	Malone, NY	243 C3
WYUL (FM)	Chateaugay, NY	234 C2

The exhibit "Co-Owned Stations" depicts the city grade contour of all three co-owned stations. The WYUL contour is from the proposed site. The combined area of these stations forms the Subject Area. The Common Area formed by these three signals is highlighted. One radio market is formed by these three stations.


The exhibit "Nearby Stations" depicts the city grade signals of nearby stations that touch the Subject Area. There are 8 nearby FM stations and 3 nearby AM stations that serve a portion of the subject area. Those nearby stations are:

The three subject stations now are added to the nearby stations to make a total of 14 services to the market.

Section 73.3555(a)(1)(iv) states: "In a radio market with 14 or fewer full-power, commercial and noncommercial radio stations, not more than 5 commercial radio stations in total and not more than 3 commercial stations in the same service (AM or FM)" may be jointly owned. Therefore the ownership of the three stations (2 FM and 1 AM) that are the subject of this Study in a market with 14 services is in compliance with the Commission's rules.

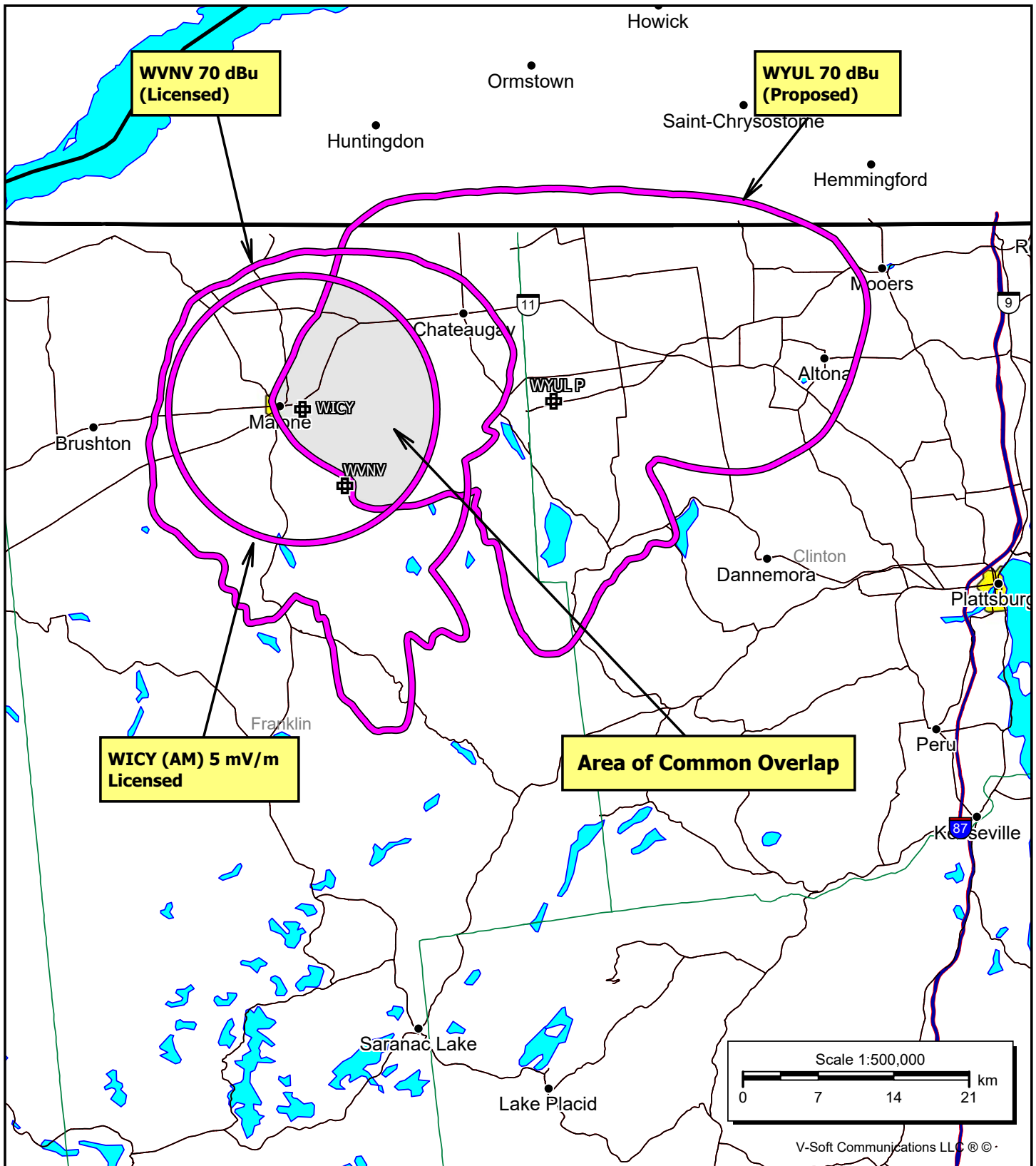

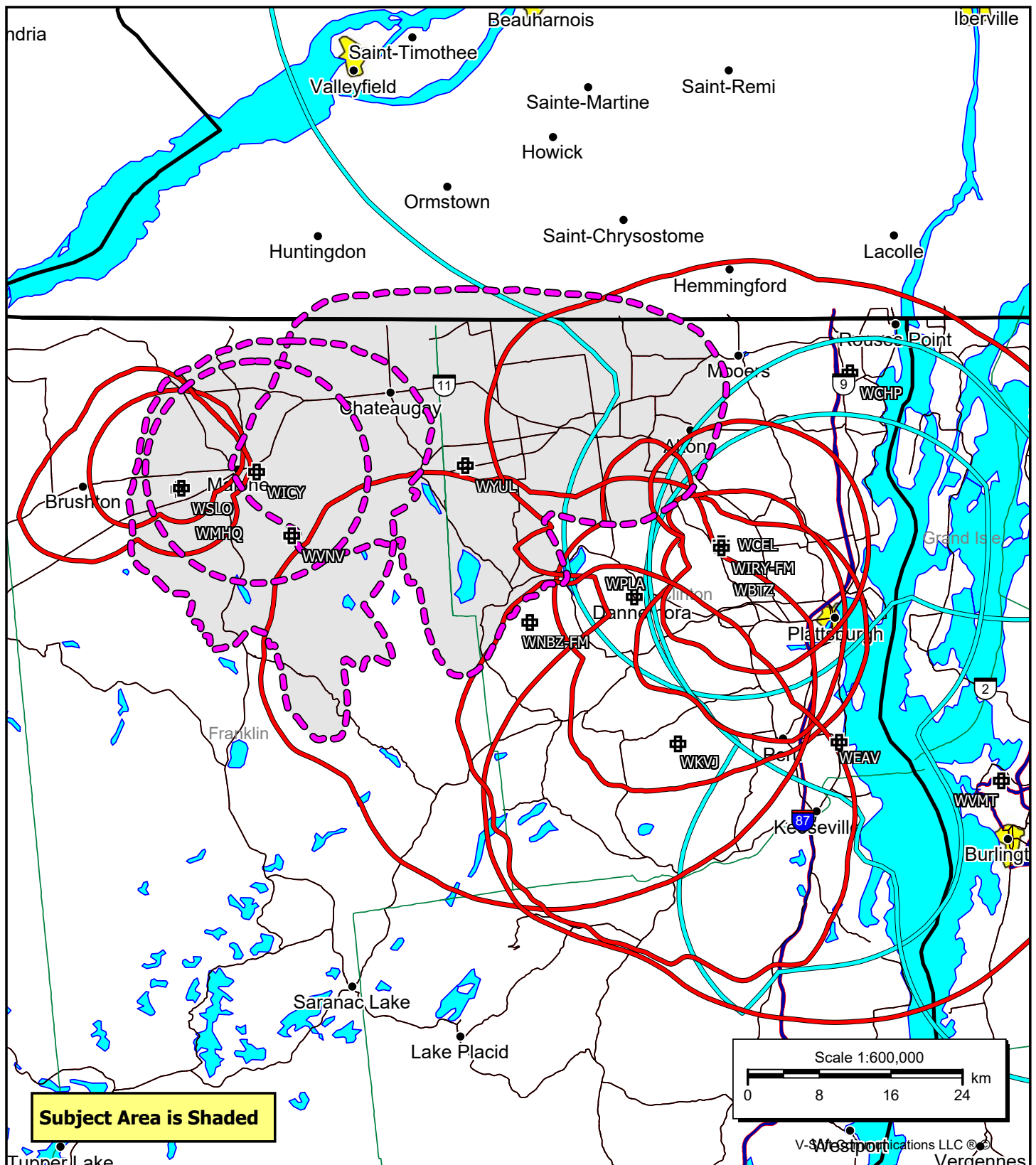
