Supplemental Recruitment Activities

The Employment Unit participated in the following Supplemental Recruitment Initiatives during the period covered by this report.

(1) Initiative: Internship Program

The employment unit operates an internship program which allows interns to gain experience in many areas of the radio industry. Internships are available year round, and students generally earn academic credits. During the period covered by this report, WLEY-FM had the following interns:

Production Department – One student from Indiana State University (October 2019 – March 2020).

(2) Initiative: EEO/Discrimination Training for Management and Personnel

All new hires review and receive employee manual that outlines equal opportunity and harassment policy. All new employees are provided credentials to complete a 2-hour workplace harassment course. Once completed they are given a certificate of completion.

(3) Initiative: Participation in Educational Institution and Community Events

- (a) On January 25, 2020 WLEY-FM participated in Dia de la Concha Fest which fundraised for Mujeres Latinas en accion non for profit. We helped promote the event by being the official station and ran PSA's for them.
- (b) On April 19, 2020 WLEY began airing a 50 minute segment every Sunday at 7:00am called *La Voz del Negocio* which airs on several SBS markets. It targets helping Hispanic small business owners and entrepreneurs and providing informative news and advice.
- (c) On January 18, 2020 and March 4, 2020 WLEY gave studio tours to students with interests in radio broadcasting. They were able to see first hand how the on air talent prepares and goes on live for the audience.
