

W205BG is currently off the air as co-owned WTTT(FM), Springfield, Illinois is currently operating on 88.9 MHz. At the present time, Covenant Network has obtained a Special Temporary Authorization for W205BG to be silent; see attached communication from the FCC.

W205BG has received a construction permit, LMS File No. 0000108292, to relocate to 88.3 MHz and become W202CJ. A copy of this construction permit is attached.

Dear Mr. Kelly:

This letter concerns the request you filed on June 3, 2020, on behalf of Covenant Network (CN), for Special Temporary Authority (STA) to permit FM Translator Station W205BG to remain silent.

CN's request states that Station W205BG went silent on May 18, 2020, pending the proposed modification of its facilities. The request includes the appropriate certification regarding Section 5301 of the Anti-Drug Abuse Act of 1988.<sup>1</sup>

CN's request is granted. Accordingly, Special Temporary Authority is granted to permit Station W205BG to remain silent not to exceed 180 days from the date of this letter. **Notwithstanding the grant of this Special Temporary Authority, the broadcast license for Station W205BG will automatically expire as a matter of law if broadcast operations do not resume by 12:01 a.m., May 19, 2021.**<sup>2</sup>

CN is required to notify the Commission when broadcast operations resume. If CN does not file the notification of resumption of operations in a timely manner, the license may be subject to cancellation pursuant to Section 312(g) of the Communications Act, as amended.<sup>3</sup>

The station's silent status does not suspend the licensee's obligation to comply with all other relevant Commission rules, including the filing, when appropriate, of applications for renewal of broadcast license. It is imperative to the safety of air navigation that any prescribed painting and illumination of the station's tower shall be maintained until removed.<sup>4</sup>

Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules(See Section 83.875).

Pursuant to Section 73.3598, this Construction Permit will be subject to automatic forfeiture unless construction is complete and application for license is filed prior to expiration.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.
