KAYW IS OPERATING AT REDUCED ERP WITH A 4.5KW TRANSMITTER. ON 7/18/2019 KAYW RESUMED OPERATIONS AT 26.5 KW ERP WITH A TPO OF 4.5KW. A RESUMPTION NOTICE WILL BE FILED WITH THE COMMISSION. AS SOON AS 3 PHASE POWER IS PROVIDED TO THE SITE, KAYW WILL FILE A LICENSE TO COVER BPH-20161212AAI AND RESUME OPERATIONS AT ERP 100 KW AS SPECIFIED IN THE CP.
