Description: TECHNICAL REASON FOR SILENT STA

A NEW TRANSMITTER WAS INSTALLED FOR KRVG BUT THE INSTALLATION OF THE NEW EQUIPMENT HAS NOT RESOLVED THE PROBLEMS WITH INTERMITTENT SHUT DOWN DUE TO LARGE AMOUNTS OF VSWR BACK FEEDING TO THE TRANSMITTER. THE TRANSMITTER HAS BEEN SHUT DOWN. APPLICANT IS IN THE PROCESS OF FILING A CP MOD TO MOVE THE TX ANTENNAS TO A DIFFERENT LOCATION ON THE SAME TOWER IN AN ATTEMPT TO AVOID THE DETRIMENTAL IMPACT OF OTHER ANTENNAS ON THE TOWER. APPLICANT RESPECTFULLY REQUESTS AUTHORITY TO REMAIN SILENT UNTIL THE CP IS GRANTED, THE NEW FACILITY IS BUILT AND LICENSED. IT IS ANTICIPATED THAT THIS PROCESS WILL TAKE AT LEAST 90 DAYS.
