E/I Symbol

The Station aired BounceTV programming on a multicast channel in 2016. Due to a technical error by BounceTV, certain CORE programming aired between September 10, 2016 – October 15, 2016, was broadcast without the E/I symbol. Additionally, one program aired on November 5, 2016 without the E/I symbol due to an error by a third-party service provider. BounceTV identified and corrected the problem. The Station re-broadcast all the episodes with the E/I symbol during 4th Quarter in addition to all regularly scheduled CORE programming.

Hi John:

Looking forward to seeing you tomorrow. I happen to be 3-1/2 miles from the studio, so I hope to be there around 9:30 or so. We'll take care of studio items, then head to the transmitter.

I went through the public file....looks very good. I only have one item to ding you on:

- The list of contracts lists the Network Affiliation agreements. This listing is supposed to be a listing of contracts in the ownership report. If someone can add these contracts to this listing, life will be good.

The following items will not affect the ABIP, but are for housekeeping purposes. Most involve too much information - very common, as the FCC pre populates much when you start the online public file and it's natural to want to leave everything in there. Here are the housekeeping items - these are based on your license period of 2014-2020:

- Applications that have been acted on, ie, granted, dismissed, etc, can be hidden as, once they are acted on, they are no longer applications.
- the 2012 renewal application can be hidden
- the form 316 can be hidden
- the transfer of control items can be hidden as they are no longer relevant.
- non current STA's can be hidden.
- All form 317 before 2014 can be hidden.
- all ownership reports that are no longer current can be hidden.
- EEO from 2012 can be hidden
- childrens reports from before 2014 can be hidden
- the 2013 childrens commercial limits certs can be hidden
- issues and programs lists from before 2014 can be hidden

– any retransmission agreements no longer current can be hidden.
