EXHIBIT 1

AMENDMENT – WXTF-LP, Harrisville, MI

STATEMENT SUPPORTING

NONCOMMERCIAL EDUCATIONAL STATUS OF ASSIGNEE

The station is a low power FM station which operates with a noncommercial educational (“NCE”) format. The proposed assignee, Alcona Music Project, Inc. (“AMP”), has not been the subject of a previously granted broadcast application; however, AMP is qualified as a NCE entity with a qualifying educational program and AMP will use the station to advance a program similar to that the Commission has found qualifying in other NCE applications.

AMP is a nonprofit educational organization and the station will be used for the advancement of an educational program.

AMP will comply with the terms of Section 73.503 of the Commission’s Rules, in that WXTF-LP will furnish a nonprofit and noncommercial broadcast service. AMP will comply with the provisions of Section 73.1212 of the Rules to the extent they are applicable to the broadcast of programs produced by, or at the expense of, or furnished by others. No promotional announcement on behalf of for profit entities shall be broadcast at any time in exchange for the receipt, in whole or in part, of consideration to AMP, its principals, or employees. However, acknowledgements of contributions can be made. The scheduling of any announcements and acknowledgements shall not interrupt regular programming, except as permitted under paragraph Section 73.503(e) of the Rules.

AMP’s Articles of Incorporation provide that the purpose of AMP is “To broaden cultural and community outreach through varied on-air music programming, education, community support and participation and fostering musical interest and artistic development within the local community.”

As assignee of WXTF-LP, in the future, it is the intention of AMP to foster via on-air programming and direct community engagement, diverse music, locally focused educational content and relevant Public Health & Service information to the entire listener community, inclusive of Alcona County’s learning institutions and libraries. AMP’s mission is to engage its community stakeholders to utilize AMP as a communication resource.

Also attached hereto is completed Section II of FCC Form 340 establishing AMP’s qualifications as an eligible NCE licensee. Since this is not an application for a new authorization, Section II, Questions 15, 16 and 17 and Section III are inapplicable.
