Good morning Hossein - I hope you are well and that you're also able to enjoy some of this spring weather!

I'm writing to get advice on how to change a community of license for a translator. Fox acquired a translator, K15MI-D (69575) in Seattle (we purchased a duopoly KZJO and KCPQ and closed March 1, 2020). It's just now come to my attention that this translator's community of license, North Bend, WA is 80+ miles from its current site. Looking at LMS, it appears the translator moved approximately in late 2002. I'll also note that the translator, which services KZJO is co-located with translator that services KCPQ - K17NX-D (33895), Centralia/Chelalis, WA. While I will not profess to be an expert on translator moves (I know practices have changed), would it be best if the community of license is updated? Any help in pointing me the right direction would be much appreciated.
