

CONTINGENT APPLICATION TO CONVERT KNKT TO NONCOMMERCIAL EDUCATIONAL STATUS

This application is contingent on the processing, grant and consummation of the simultaneously filed pending application seeking consent to assignment of license of KNKT(FM), Armijo, NM, from Calvary Albuquerque, Inc. ("CAI"), to Bible Broadcasting Network, Inc. ("BBN"). Pursuant to Section 73.3517(e) of the Rules, the Commission will accept up to four contingently related applications filed by FM licensees and/or permittees for minor modification of facilities. These applications are related since the grant of one is necessary to permit the grant of the second application. This application is filed as part of a related group of applications to make changes in facilities, and cross-references the other related application, and includes a copy of CAI's permission to file this application.

This application seeks to convert KNKT, Armijo, NM, from commercial to noncommercial educational status. Attached hereto is a copy of the consent of CAI to file this contingent application pursuant to section 73.3517 of the Rules.

Also attached is Section II (legal section) from FCC Form 340 (application for construction permit for reserved noncommercial educational broadcast station), providing pertinent legal information and setting forth a list of BBN's licensed facilities.
